OPINION AND ORDER

By this application, William J. Knoell, Agent, in behalf of some 110 highway common and petroleum irregular route carriers, seeks authority under Section 454 of the Public Utilities Code, to increase certain rates for the transportation of bulk petroleum products in tank trucks from, to and between points situated on the highway known as "Panoche Road" between Panoche (San Benito County) and State Highway No. 33. The rates in question are distance rates published in Agent Knoell's Tariff No. 3-D.¹ These rates are subject to mileages in Agent Knoell's Distance Table No. 4.² The rate increases are proposed to be accomplished by providing by rule in the tariff that the distance table mileages along the indicated portion of Panoche Road which reflect actual mileages shall be increased by 72 percent when used in applying the distance rates.³

 - 3 The rule proposed is, in part, as follows:

When it is necessary to compute the actual mileage of any segments of the direct highway known as Panoche Road as shown on the applicable distance table maps between Panoche and California State Highway No. 33, said actual mileage shall be increased in the amount of 72 percent before it is used in connection with any mileage rates named herein.

The application shows that the mileages in Agent Knoell's distance table between Panoche or State Highway No. 33, on the one hand, and the points intermediate thereto on Panoche Road, on the other hand, or between the aforesaid intermediate points, reflect actual mileage, whereas the distance table provides a mileage of 55 miles between Panoche and State Highway No. 33, which is 72 per-⁴cent higher than the actual mileage of 32 miles between these points. The application also shows that Panoche Road is in poor condition and not usable by tank trucks and trailers transporting petroleum products, and that carriers are required to detour over a circuitous route from, to and between points intermediate between the basing points of Panoche and State Highway No. 33. Applicant states that the sought provision was the subject of a docket hearing of the Tank Truck Operators Tariff Bureau Standing Rate Committee attended by interested shippers on June 19, 1957, and that no objection was made.

Interested parties have been furnished a copy of this application. No objection has been received to its being granted.

In the circumstances, it appears, and we hereby find that the rate increases which would result from the filing of the proposed rule are justified. A public hearing is not necessary.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that William J. Knoell, Agent, is hereby authorized to publish the proposed rule as set forth in this application in Tank Truck Operators Tariff Bureau Local Freight

⁴The mileages in Agent Knoell's distance table are on the same level as the constructive mileages prescribed by the Commission. Constructive mileages are the actual distances increased where, and to the extent, found necessary to give effect to adverse conditions, such as grades, curvatures, poor road surfaces, traffic congestion and bridge and ferry tolls.

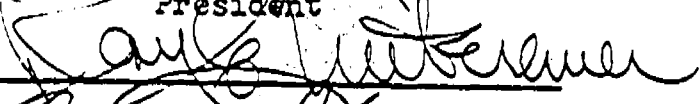

IT IS HEREBY FURTHER ORDERED that the authority herein granted shall expire unless exercised within sixty days after the effective date of this order.

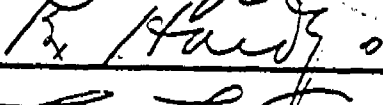
The effective date of this order shall be twenty days after the date hereof.
