In the Matter of the Application of TUOLUMNE TELEPHONE CO.

- (1) To enter into a loan agreement with the United States of America under and pursuant to the Rural Electrification Act of 1936, as amended, acting through the Administrator of the Rural Electrification Administration;
- (2) To execute its promissory notes to said United States of America in the sum of \$202,000, said obligation to bear interest at the rate of two per cent per annum;
- (3) To execute and deliver a mortgage of realty and chattels covering all of the properties of applicant as security for the payment of said obligation;
- (4) To apply the proceeds derived from said notes to the expansion, rehabilitation and improvement of the plant and facilities of said company and to the discharge of certain obligations of the company.

FIFTH SUPPLEMENTAL ORDER

By Decision No. 54467, dated February 5, 1957, in the above-entitled matter, the Commission authorized Tuolumne Telephone Co. to issue \$202,000 of notes to the United States of America, acting through the Rural Electrification Administration and, subject to further authorization, to use the proceeds for the purpose of expanding, rehabilitating and improving its facilities and service, of refinancing indebtedness and of providing working capital. The authorization of the Commission required applicant to file a copy of each requisition

Applicant now seeks approval for additional expenditures of \$63,722.17 from the loan funds. A statement showing the estimated expenditures, the requisitions heretofore approved and the amount now requested, is as follows:
