O P I N I O N

Applicant requests authority to make a minor route change in the operation of its Line 12 - Los Angeles-San Fernando by re-routing its terminal loop in the City of San Fernando via Truman Street and Workman Street to San Fernando Road, instead of via Truman Street, North Brand Boulevard, First Street and Maclay Avenue to San Fernando Road. There will be no change in the equipment used, fares charged or time schedules.

The proposed change has been suggested by the City of San Fernando as an operational and safety improvement. We find the proposal to be in the public interest and the application will be granted. A public hearing is not deemed necessary.

O R D E R

Application having been made, the Commission being fully advised in the premises, and good cause appearing,

IT IS ORDERED:

- (1) That Asbury Rapid Transit System, a corporation, may re-route its Line 12 - Los Angeles-San Fernando between the intersection

of Truman Street and North Brand Boulevard and the intersection of San Fernando Road and Maclay Street by operating along Truman Street, Workman Street and San Fernando Road.

(2) That Appendix A to Decision No. 53719 is hereby amended by incorporating therein First Revised Page 1 of Appendix A attached hereto and made a part hereof.

LINE 12 - LOS ANGELES-SAN FERNANDO

From 11th Street and Main Street (Los Angeles), thence via Main Street, Spring Street, New High Street, Ord Street, Castelar Street, Pasadena Freeway, Figueroa Place, Avenue 26, San Fernando Road and Truman Street to Workman Street (San Fernando).

Return via Workman Street, San Fernando Road and reverse of above route to intersection of New High Street, Spring Street, and Sunset Boulevard (Los Angeles), thence via Sunset Boulevard, Los Angeles Street and 11th Street to Main Street.

ALTERNATE ROUTES

1. From San Fernando Road and Lincoln Street (Burbank), thence via Lincoln Street, Empire Avenue, Lockheed Aircraft Corporation roadway, and Hollywood Way to San Fernando Road.
2. From Hollywood Way and San Fernando Road (Burbank), thence via Hollywood Way, Glenoaks Boulevard, Osborne Place, and Osborne Street to San Fernando Road.
3. From Magnolia Boulevard and San Fernando Road (Burbank), thence via Magnolia Boulevard, Glenoaks Boulevard, Osborne Place and Osborne Street to San Fernando Road.

RESTRICTIONS

- A. No passengers shall be picked up south of 9th Street northbound or discharged south of 8th Street southbound.
- B. No passengers shall be picked up or discharged on the Pasadena Freeway.
