TWELFTH SUPPLEMENTAL OPINION AND ORDER

Prior orders in this proceeding have authorized applicant to deviate from the established minimum rates in connection with specialized transportation services it performs for Sears, Roebuck and Company between that company's warehouses and retail stores in San Francisco and Emeryville and from its retail stores to customers within 35 miles of San Francisco. This authority is scheduled to expire January 13, 1958. Permission is sought to continue to deviate from the minimum rates for a further one-year period. Applicant proposes increases in its present minimum charges so as to make them no lower than those recently prescribed by the Commission in Minimum Rate Tariff No. 2, Item No. 150-L, for distances not exceeding 150 constructive miles.

According to the verified supplemental application, the conditions surrounding the transportation in question which justified deviation from the minimum rates still obtain, and operations under the sought rates may reasonably be expected to be profitable.

Competing carriers have been notified of the filing of the supplemental application. No objections have been received.

In the circumstances, it appears, and the Commission finds, that the proposed rates are reasonable and consistent with the public interest. This is a matter in which a public hearing is not

necessary. The supplemental application will be granted. In view of the expiration date of present authority, the order herein will be made effective January 13, 1958.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that Decision No. 49208 of October 13, 1953, as amended, in this proceeding, be and it is hereby further amended by substituting in Item No. 1 of Appendix "A-2" of Decision No. 53695 of August 29, 1956, the following minimum charges for those shown therein:

Over	45	but	not	over	59 pounds	1.75
Over	59	but	not	over	100 pounds	2.10

IT IS HEREBY FURTHER ORDERED that the expiration date of the authority granted by said Decision No. 49208, as further amended herein, be and it is hereby extended to January 13, 1959, unless sconer changed or further extended by order of the Commission.
