## SUPPLEMENTAL ORDER

An order was sought herein authorizing the sale and transfer of an operative right for an "on-call" service between El Cajon, on the one hand, and San Diego, on the other hand. The Commission in Decision No. 55214 inadvertently misdescribed the operative right the transfer of which was authorized therein.

Applicants having requested the Commission to correct such misdescription, Now Therefore,

IT IS ORDERED that Ordering Paragraphs (1) and (6) of Decision No. 55214 are amended to read:

"(1) That Herman Neumann, after the effective date hereof, and on or before March 1, 1958 may sell and transfer to Wayne Alvin Fields, and the latter may acquire that portion of the operative right granted by Decision No. 52236, dated November 14, 1955, in Application No. 37279, between El Cajon, on the one hand, and San Diego, on the other hand, subject to the following conditions and restrictions:

> (a) Service shall be operated on an "on-call" basis and shall be made only upon demand of a minimum of twenty passengers.

  - (b) No passengers shall be transported whose origin and destination are along Main Street, between Anza Street and Johnson Avenue, in the City of El Cajon, or whose origin and destination are west of the intersection of Alvarado Freeway and 70th Street, in the City of San Diego.
  - (c) No passengers shall be picked up or discharged along Main Street, between Johnson Avenue and Anza Street, whose destination or origin is San Diego.
  - (d) The transportation of baggage or express shall be on passenger-carrying vehicles and shall be incidental to the transportation of passengers and limited to a weight of not more than one hundred (100) pounds per shipment.

Subject to the authority of this Commission to change or modify it at any time, Wayne Alvin Fields shall conduct said passenger stage operations over and along the following described route:

Beginning at the intersection of Broadway and 2nd Street, thence along Broadway, U. S. Highway 80, Main Street, Cuyamaca Street, Broadway, Lake Murray Boulevard, Alvarado Freeway, Camino del Rio, U. S. Highway 101, Broadway (in the City of San Diego), Harbor Drive, to Market Street.

Applicant is authorized to turn its motor vehicles at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, or in accordance with local traffic rules.

"(6) That the portion of the operative right granted Herman Neumann by Decision No. 52236, the transfer of which is authorized by Paragraph (1) hereof, is deleted from said decision and
