## OBINICN

Applicant requests authority to reroute that portion of its Route "C" - 30th Street-Naval Station line in National City between the intersection of 32d Street and Main Street and Gate 9 of the U. S. Naval Station by operating along Main Street, Roosevelt Avenue and 8th Street, thence leaving said station through Gate 6, thence via 32d Street to Main Street. Applicant is now operating along said route on a temporary detour.

The proposed route is not competitive with that of any other carrier. Applicant does not propose any change in fares, schedules or equipment operated.

Applicant alleges that the proposed change is necessary because of a congested traffic condition at the intersection of 32d street and Harbor Drive which causes delay, and also because of difficulty in making a left turn at said intersection. The City Traffic Engineer and the Commission's engineering staff favor the proposed change. The change is not opposed and as it appears to be in the public interest the application will be granted. A public hearing is not deemed necessary.

## <u>O R D E R</u>

Application having been made, the Commission finding that public convenience and necessity so require,

IT IS ORDERED that San Diego Transit System, a corporation, may reroute its Route "C" - 30th Street-Naval Station line, and Appendix A to Decision No. 55090 is hereby amended by incorporating therein First Revised Page 9 of Appendix A attached hereto and made a part hereof.

## ROUTE "C" - 30TH STREET NAVAL STATION

From the intersection of Adams Avenue and 30th Street, via 30th Street, Upas Street, 30th Street, Fern Street, 30th Street, Market Street, and 32d Street to Main Street, then loop via Main Street, Roosevelt Avenue in National City, and 8th Street, entering the United States Naval Station through Gate 9, which is opposite the intersection of 8th Street and Harbor Drive, and leaving the United States Naval Station through Gate 6, which is opposite the intersection of Harbor Drive and 32d Street, then via 32d Street to Main Street.
