<u>O P I N I O N</u>

Crest Messenger & Delivery Service, Inc., is a highway carrier engaged in the transportation of property in California pursuant to permits issued it by this Commission.

Crest Messenger & Delivery Service, Inc., seeks an order authorizing it to conduct service as a highway common carrier for the transportation of general commodities in the Los Angeles area.

Notice of filing of the application was given all common carriers subject to the jurisdiction of this Commission.

It appears that applicant possesses the experience, equipment, personnel and financial resources to institute and maintain the proposed operation.

Upon consideration of the allegations of the application as amended and the representations filed pursuant to the abovementioned notice, the Commission finds that public convenience and necessity require that the emended application be granted to the extent set forth in the ensuing order. A public hearing is not necessary.

Applicant is hereby placed upon notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be changed or destroyed at any time by the State, which is not in any respect limited as to the number of rights which may be given.

<u>O R D E R</u>

The Commission having considered the application as amended and representations filed herein, now therefore


IT IS ORDERED:

(1) That a certificate of public convenience and necessity is granted to Crest Messenger & Delivery Service, Inc., authorizing it to operate as a highway common carrier as defined by Section 213 of the Public Utilities Code for the transportation of property between the points as more particularly set forth in Appendix A attached hereto and made a part hereof.

(2) That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

(b) Within sixty days after the effective date hereof, and on not less than ten days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs satisfactory to the Commission.

Appendix A

CREST MESSENGER & DELIVERY SERVICE, INC.

Crest Messenger & Delivery Service, Inc., by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport general commodities between Bandini, Beverly Hills and Vernon.

The authority hereinabove set forth does not include the right to render service to, from, or between intermediate points, subject to the following conditions:

- (a) Applicant shall not transport any shipment weighing in excess of 500 pounds.
- (b) Applicant shall not transport any shipments of:
 - Used household goods and personal effects not packed in accordance with the crated property requirements set forth in paragraph (d) of Item No. 10-C of Minimum Rate Tariff No. 4-A.
 - Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis; freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.
 - Livestock, viz.: bucks, bulls, calves, cattle, cows, dairy cattle, ewes, goats, hogs, horses, kids, lambs, oxen, pigs, sheep, sheep camp outfits, sows, steers, stags or swine.

- 4. Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerated equipment.
- 5. Liquids, compressed gases, commodities in semiplastic form and commodities in suspension in liquids in bulk, in tank trucks, tank trailers, tank semitrailers or a combination of such highway vehicles.
- 6. Commodities when transported in bulk in dump trucks or in hopper-type trucks.
- 7. Commodities when transported in motor vehicles equipped for mechanical mixing in transit.
