FIRST SUPPLEMENTAL OPINION AND ORDER

By the above-entitled application filed February 20, 1958, Pacific Gas and Electric Company requests authority to carry out the terms and conditions of an agreement dated December 12, 1957 with the City of Ukiah. Said agreement provides for the extension of Pacific's electric distribution facilities and for the sale and delivery therefrom of all electricity required for the operation of a new sewage pumping plant of the City of Ukiah. A copy of the agreement is attached to the application and marked Exhibit B.

The agreement dated December 12, 1957 is a supplemental agreement to the existing contract between Pacific and Ukiah, dated November 14, 1955, under which all of the electricity required by Ukiah for its own use and for resale to its customers is secured from Pacific. Said existing contract was authorized by the Commission in Decision No. 52630, dated February 14, 1956.

Since August 31, 1955, Pacific has been selling and delivering all of the electricity required by Ukiah under the terms of the existing contract. This electricity is delivered at 12,000 volts at (a) the point where the electrical conductors of Pacific connect with those of Ukiah at Pacific's pole on River Road east of Orchard Street near the easterly corporate limits of the City of Ukiah and (b) Ukiah's existing sewage pumping plant located outside the corporate limits of the City of Ukiah on River Road west of the Russian River. For billing purposes the quantity of electricity delivered at the sewage pumping plant is added to that delivered at the point of delivery east of Orchard Street.

The supplemental agreement dated December 12, 1957 amends the delivery condition set forth in the addendum of the existing contract. Ukiah is constructing a new sewage pumping plant located approximately 4,000 feet south of the Ukiah Airport and east of the Northwestern Pacific Railroad right-of-way, and has requested Pacific to extend its electric distribution line and to sell and deliver all of the electricity which will be required at the new sewage pumping plant. In order to comply with Ukiah's request, it will be necessary for Pacific to furnish and install approximately 1,523 feet of the three-phase 12,000-volt electric distribution line, current transformers, metering equipment, service drop and other associated equipment at a cost of approximately \$2,744, all of which will be installed by Pacific at its own cost and expense. The quantity of

electricity delivered at the new sewage pumping plant will, for billing purposes, be added to the quantities of electricity delivered at the aforementioned point of delivery east of Orchard Street. Pacific will continue to deliver electricity to Ukiah for the operation of the aforementioned existing sewage pumping plant until such time as Ukiah shall notify Pacific that electric service to said existing plant will no longer be required, or until December 31, 1958, whichever is the earlier date.

Pacific states that it has given careful consideration to all the facts and circumstances bearing upon the matters involved and believes that the supplemental agreement dated December 12, 1957 and its terms and conditions are, under the circumstances obtaining, fair, just and reasonable to the parties thereto.

The supplemental agreement contains the provision that it shall not become effective until the Commission shall, by its order, authorize Pacific to carry out the terms and conditions thereof and shall at all times be subject to such changes or modifications by the Commission as it may, from time to time, direct in the exercise of its jurisdiction.

The Commission having considered the above-entitled application and being of the opinion that the application should be granted and that a public hearing thereon is not necessary; therefore,

IT IS HEREBY ORDERED that Pacific Gas and Electric Company be and it is authorized to carry out the terms and conditions of the supplemental agreement with the City of Ukiah dated December 12, 1957,

and to render the service described therein under the terms, charges, and conditions set forth therein.

IT IS FURTHER ORDERED that Pacific Gas and Electric Company shall file with this Commission a statement promptly after termination of said supplemental agreement, showing the date when the agreement was terminated.

The effective date of this order shall be twenty days after the date hereof.
