#### OPINION

San Jose City Lines, Inc., requests authority to extend and amend several routes and to make certain changes in service frequencies.

A public hearing was held before Examiner Thomas E. Daly on February 25, 1958, at San Jose and the matter was submitted.

Authority is sought to combine certain portions of Routes Nos. 2 and 4; to extend Route No. 3 to a newly developed and recently annexed residential area along Foxworthy Avenue; and to extend its Route No. 5 to the Valley Fair Shopping Center. On

Route No. 3 it is proposed that a fare zone be established at the intersection of Husted Avenue and Lincoln Avenue and that a 5-cent fare be charged in addition to the basic cash fare of 10 cents or token fare of 9 cents for those passengers traveling beyond the proposed fare zone point.

The proposed extension to the Foxworthy area would be competitive with the service of Almaden Stage Lines, and the extension to the Valley Fair shopping area would be directly competitive with the services of Peerless Stages and Mayfair Suburban Lines for a distance of approximately one-half mile along Stevens Creek Road.

The city manager of the city of San Jose testified that, as a result of numerous demands by residents of the affected areas, the city requested applicant to make the extensions herein proposed.

Representatives of the Valley Fair Shopping Center and Macy's testified that the proposed extension of Route No. 5 would be a convenience to shoppers and employees of the various stores. The protest of Peerless Stages, Inc., was primarily directed toward the fact that applicant proposes to serve the shopping area via Stevens Creek Road. It was indicated that Peerless Stages, Inc., would have no objection to the applicant serving Valley Fair if it did so via Forest Avenue.

Residents of the Foxworthy area testified in support of the proposed extension of Route No. 3. They stated that the existing service of Almaden Stage Lines is inadequate and undependable. It was asserted that schedules are often either missed or late, the may deviate from the route hereinafter authorized and use the streets necessary to detour around the construction work on Forest Avenue.

The record further indicates that the proposed extension of Route No. 3 along Foxworthy Avenue may materially affect the operations of Almaden Stage Lines but this carrier has been unable to meet the growing demands of the area. The people of this area are entitled to the benefits and privileges that would be afforded through the use of applicant's extensive and integrated service.

After consideration the Commission is of the opinion and finds that public convenience and necessity require the granting of the authority as hereinafter specified.

(4) That in providing service applicant may deviate from the route herein authorized and use the streets necessary to detour around the construction work on Forest Avenue.

The effective date of this order shall be twenty days after the date hereof.
