In the Matter of the Application of SAN DIEGO TRANSIT SYSTEM, a corporation, for authority to reverse the loop on the north end of its Route 5 - Clairemont-Market Street line.

OPINION

Applicant requests authority to reverse the loop operation at the north end of its <u>Route 5 - Clairemont-Market Street</u> line by operating via Moraga Avenue from the intersection of Moraga Avenue and Clairemont Mesa Boulevard instead of via Clairemont Mesa Boulevard.

The proposed change is necessary in order to conform with the general traffic pattern in the vicinity of Jutland Drive and Luna Avenue.

The application is not opposed.

The Commission finds that public convenience and necessity require the proposed change and therefore will grant the application. A public hearing is not deemed necessary.

ORDER

Application having been made, the Commission being fully advised in the premises and having found that public convenience and necessity so require,

IT IS ORDERED:

- (1) That applicant may reroute a portion of its Route 5 Clairemont-Market Street line as hereinabove set forth, and Appendix A to Decision No. 55090 is hereby amended by incorporating therein Second Revised Page 25 of Appendix A attached hereto and made a part hereof.
- (2) That in providing service pursuant to the certificate heretofore granted, there shall be compliance with the following service regulations:

Within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and the public, applicant shall establish the services herein authorized and file in triplicate and concurrently make effective tariffs and time schedules satisfactory to the Commission.

The effective date of this order shall be the date hereof.

Route 5 - Clairemont-Market Street

From the intersection of Clairemont Mesa Boulevard and Moraga Avenue, loop via Moraga Avenue, Idlewild Way, Jutland Drive, Luna Avenue, and Clairemont Mesa Boulevard to Moraga Avenue, then via Clairemont Mesa Boulevard, Clairemont Drive, Burgener Boulevard, Milton Street, Morena Boulevard, Taylor Street, San Diego Avenue, California Street, Winder Street, India Street, Laurel Street, and State Street to Beach Street, thence eastbound only via Beech Street, Union Street, A Street, 4th Avenue, and Market Street to 5th Avenue, thence via Market Street, 47th Street, Federal Boulevard, Euclid Avenue, 54th Street, Streamview Drive, Lynn Street, Thorn Street, Glade Street, Streamview Drive, College Avenue, Racine Road, Vista Grande Drive, Celia Vista Drive, Hoffman Avenue, and Massachusetts Avenue to University Avenue.

Also, from the intersection of Market Street and 5th Avenue, northbound only via 5th Avenue, B Street, and State Street to Beech Street.

Also, from the intersection of Clairemont Drive and Clairemont Mesa Boulevard, via Clairemont Mesa Boulevard to Genesee Avenue.

Also, from the intersection of Streamview Drive and 54th Street, via 54th Street to Collier Avenue.
