OPINION

Lewis Rodgers doing business as Fresno-Bass Lake Freight Lines, presently rendering service as a highway common carrier between Fresno, Wawona, Sugarpine, Bass Lake, North Fork and intermediate points requests authority to extend service on an on-call basis to such points as Beasore Meadow, Hogue Ranch, Soda Springs, Logan Meadow, Fuller Meadow, Arnold Meadow, Forked Meadow, Long Meadow, Mammoth Pool, Placer Guard Station, Italian Bar and Dam No. 7.

As justification for the authority sought applicant alleges that these smaller communities are dependent upon service between Fresno and other points that he is authorized to serve; that no present service is provided and that he has received numerous requests to serve the small communities, ranches, and mills located northeast of Fresno.

After consideration the Commission is of the opinion and so finds that public convenience and necessity require the granting of the authority sought. A public hearing does not appear to be necessary. For the purpose of convenient maintenance of records an in-lieu certificate will be issued in an appendix form.

(3) That the operative rights granted by Decision No. 40885 dated November 11, 1947, in Application No. 28755 are hereby revoked.

Lewis Rodgers by the certificate of public convenience and necessity granted in the decision noted below, is authorized to transport property as follows:

- (1) Between Fresno and Wawona via State Highway No. 41; and also via Friant, Oneals, North Fork and Bass Lake; and all intermediate points.
- (2) Between Bass Lake and Wishon Powerhouse on the San Joaquin River, and all intermediate points, on an on-call basis.
- (3) Service is authorized by diversion to and from South Fork and Indian Mission.
- (4) Between Bass Lake and Clover (Glover) Meadows and intermediate points, on an on-call basis.
- (5) Between Auberry Road and Friant and intermediate points, on an on-call basis.
- (6) The main roads connecting the aforementioned routes and points located thereon.

The Following Shall Be On An On-Call Basis.

- (7) Between North Fork and Beasore Meadow, via South Fork, Hogue Ranch, Soda Springs, Long Meadow.
- (8) Between Long Meadow and Fullers Meadow, via Arnold Meadow, Forked Meadow, Logan Meadow and Mammoth Pool.
- (9) Between Soda Springs and Forked Meadow, via Placer Guard Station.
- (10) Between Big Creek Power House No. 4 and Italian Bar via Dam No. 7.
- (11) All intermediate and off-route points of Castle Peak and Lake Redinger.
- (12) Traversing all unnumbered county roads between the above-named points.
