

<u>OPINION</u>

Public hearing was held on this matter on March 31, 1958, in Los Angeles before Examiner Grant E. Syphers, at which time evidence was adduced and the matter submitted. It now is ready for decision.

The applicant presently conducts a sightseeing service from the City of Santa Monica to various points, and in the instant application seeks to extend this service by operating three additional tours. Tour No. 2B is proposed to be operated from the Santa Monica territory, the Culver City territory and a portion of Los Angeles. County generally north of Beverly Boulevard, west of Sycamore Street, east of Doheny Drive, and south of the Santa Monica mountains, on the one hand, to Beverly Hills and Hollywood, following generally the same route as applicant's existing Tour No. 2. Tour No. 3B is intended to operate from the three above-mentioned territories to

Los Angeles, generally following the route of applicant's existing Tour No. 3. Tour 6B is intended to operate from these three territories to Disneyland and Knott's Berry Farm, generally following applicant's existing Tour No. 6.

Public witnesses appeared in favor of these proposals. Three of these witnesses are owners or operators of hotels and motels in the areas who testified they have had requests for sightseeing tours of the type proposed. Likewise the applicant presented similar testimony. There was no opposition to these proposals.

Financial statements of applicant were submitted and according to testimony presented concerning them these proposed tours would supplement applicant's existing operations and would tend to provide additional income.

Applicant proposes to use two 15-passenger extended limousines; one of these has already been purchased. The rates to be charged are similar to the rates being charged for existing tours.

The service proposed is similar to existing service of applicant in that it will be on call with the restriction that applicant will not be required to make a trip with less than four adult fares for all tours except the Disneyland tour and, for that tour, five or more adult fares.

A representative of the City of Los Angeles requested that applicant be restricted against making any pickup's in the City of Los Angeles unless it obtained the necessary permits from that city.

In the light of all of this evidence we find that public convenience and necessity require a sightseeing service as proposed. The application will be granted.

Inasmuch as these tours are additions to applicant's existing rights and for the purpose of supplementing that service, an in lieu certificate will be granted herein incorporating all of applicant's operating authority.

A public hearing having been held, the Commission being fully advised in the premises and having found that public convenience and necessity so require,


IT IS ORDERED:

(1) That a certificate of public convenience and necessity be and it hereby is granted to Charles H. Metzger authorizing him to establish and operate a service as a "passenger stage corporation", as defined in Section 226 of the Public Utilities Code, for the transportation of persons between the points and over the routes more particularly set forth in Appendix A, attached hereto and made a part hereof, subject to the conditions and restrictions, if any, set forth in said appendix.

(2) That in providing service pursuant to the certificate herein granted, there shall be compliance with the following service regulations:

> (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed upon notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 98. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 98, may result in a cancellation of the operating authority geanted by this decision.




(b) Within sixty days after the effective date hereof and upon not less than five days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate and concurrently make effective tariffs and time schedules satisfactory to the Commission.

IT IS FURTHER ORDERED that all operating authority heretofore granted to this applicant, other than that granted herein, be, and it hereby is canceled, effective upon the date that the operating authority granted herein takes effect.

The effective date of this order shall be twenty days after the date hereof.

Charles H. Metzger, doing business as Santa Monica Sightseeing Service, by the certificate of public convenience and necessity granted in the margin, is authorized to operate a round-trip sightseeing service for the transportation of persons between the points and over the routes hereinafter set out, subject, however, to the authority of this Commission to change or modify said routes at any time, and subject to the following conditions:

- (a) Applicant shall not pick up or discharge passengers within the City of Los Angeles. This restriction shall not prevent stopovers for the purpose of permitting sightseeing passengers to visit various points of interest along the route.
- (b) Applicant shall not be obligated to perform said sightseeing service for less than five adult passengers.

Tour No. 1

Commencing at the Carmel Hotel at Broadway and Second Street in Santa Monica, thence via Second Street, Main Street, Pico Boulevard, Ocean Avenue to its intersection with Bicknell Avenue, northerly on Ocean Avenue to Roosevelt Highway (U. S. 101), thence via Roosevelt Highway, Sunset Boulevard, Fairfax Avenue, Wilshire Boulevard, Roxbury Drive, Olympic Boulevard, Barrington Avenue, National Boulevard, Bundy Drive, Ocean Park Boulevard, Twenty-sixth Street, Pico Boulevard, Nineteenth Street, California Street, Third Street, Broadway to point of beginning. Service is authorized to all intermediate points and to the off-route points of the Municipal Pier in Santa Monica, Will Rogers Memorial near 14253 Sunset Boulevard, and Howard's Flowerland near National Boulevard and Barrington Avenue.




