#### FIRST SUPPLEMENTAL ORDER

Good cause appearing,

IT IS HERSBY ORDERED that Ordering Paragraph 5 of the order in Decision No. 54064, dated November 13, 1956, be, and it hereby is, amended to read as follows:

"5. San Gabriel Valley Water Company, within 30 days after the effective date of this order, shall establish and thereafter maintain as a part of its accounting records a memorandum account or accounts in which it shall record the gross and net adjustment to its rate base relating to purchases from Vesco and subsequent charges thereto representing annual accruals applicable to the gross adjustment computed at the rate of 6% annually on the amount of such gross adjustment."

This first supplemental order is effective upon the date hereof.

# The Pacific Telephone and Telegraph Company's Study - Del Rey Exchange

The Del Rey exchange, owned and operated by The Pacific Telephone and Telegraph Company, is located some 12 miles southeast of the center-of Fresno and involves a 15-cent initial period station toll charge that would be eliminated under extended service. The Pacific Company's study showed the following results:
