## THIRTEENTH SUPPLEMENTAL OPINION AND ORDER

Prior orders in this proceeding have authorized applicant to deviate from the established minimum rates in connection with specialized transportation services it performs for Sears, Roebuck and Company between that company's warehouses and retail stores in San Francisco and Emeryville and from its retail stores to customers within 35 air miles of San Francisco. Decision No. 56040 of January 7, 1958, in this proceeding, authorized applicant to continue to deviate from the minimum rates until January 13, 1959, with designated increases in the minimum charges applicable thereto as requested.

By supplemental application, as amended on April 24, 1958, applicant seeks authority to reduce certain of the minimum charges to their former level. Applicant avers that it has carefully reviewed the effect of this proposal upon its revenues and is satisfied that it can perform this transportation at a satisfactory profit under the modification proposed herein.

The supplemental application, and the amendment thereto, were mailed to interested parties on or about March 3 and April 24, 1958, respectively. No objection to its being granted has been IECEIVEA.

## A. 29587 - AHS

In the circumstances, it appears, and the Commission finds, that the proposed minimum charges are reasonable and consistent with the public interest. This is a matter in which a public hearing is not necessary. The supplemental application, as amended, will be granted.

Therefore, good cause appearing,

IT IS ORDERED that Decision No. 49208 of October 13, 1953, as amended, in this proceeding, is hereby further amended by substituting in Item No. 1 of Appendix "A-2" of Decision No. 53695 of August 29, 1956, the following minimum charges for those shown therein:

Column 1 charges apply to distances not in excess of 35 miles from point of origin to destination.

Column 2 charges apply to distances in excess of 35 miles from point of origin to destination.

In all other respects said Decision No. 49208, as amended, shall remain in full force and effect.

This order shall become effective twenty days after the date hereof.
