ORDER REVOKING OPERATIVE RIGHTS

By Decision No. 52392 dated December 20, 1955, in this proceeding, William James Ginther was granted a certificate of public convenience and necessity to operate as a highway common carrier of specified commodities between Los Angeles and San Gabriel, on the one hand, and certain points intermediate to Perris, Hemet, Coachella and Twentynine Palms, on the other hand.

William James Ginther does not have on file evidence of liability insurance as required by General Order No. 100-A. His permits to operate as a radial highway common carrier, a highway contract carrier, and a household goods carrier have been suspended. The Commission has been informed that he no longer operates as a common carrier. On November 15, 1957, his participation in the classification governing his tariff rates was canceled.

The certificate of public convenience and necessity issued by Decision No. 52392 in this proceeding will be revoked and Ginther's powers of attorney and participation in agency tariffs will be canceled.

Therefore, good cause appearing,

IT IS ORDERED:

- (1) That the certificate of public convenience and necessity granted to William James Ginther by Decision No. 52392, dated December 20, 1955, in this proceeding, is revoked.

(2) That J. L. Beeler, Agent of Southwestern Motor Tariff Bureau, and J. P. Hackler, Alternate Agent of Western Classification Committee, are authorized and directed to cancel, on not less than five days' notice to the Commission and the public, the participation of William James Ginther from their tariffs on file with this Commission.

(3) That Powers of Attorney AF1 Nos. 1 and 2 issued by William James Ginther in favor of J. L. Beeler, Agent, and J. P. Hackler, Alternate to Geo. H. Dumas, Agent, respectively, are canceled.

The Secretary of the Commission is hereby directed to cause a certified copy of this order to be served upon William James Ginther in the manner prescribed by law.

The effective date of this order shall be the twentieth day after lawful service thereof unless William James Ginther before such effective date shall have filed with this Commission a written response to this order denying the facts set forth herein and requesting a public hearing thereon, in which event the effective date of this order shall hereby be stayed until a hearing is held and a further order is issued.
