In the Matter of the Application of SANTA PAULA WATER WORKS, LTD., a corporation, for an Order authorizing it to enter into agreement with George M. Atmore and Helen M. Atmore, husband and wife, under which it will transfer priorities under certain water rights owned by it.

OPINION AND ORDER

Santa Paula Water Works, Ltd., a corporation, by the above-entitled application filed May 12, 1958, seeks authorization of this Commission to carry out the terms and conditions of an unexecuted agreement with George M. Atmore and Helen M. Atmore, his wife, dated May 1, 1958.

The agreement provides that the Atmores may take water from Bear Canyon, a tributary of Santa Paula Creek, for the purpose of irrigating their garden and yard. The amount to be taken is not to exceed 65,340 cubic feet of water per year or 179 cubic feet in any 24 hour period. The consideration for the right to take such water is to be \$45.31 per year. The agreement is to remain in effect from year to year until terminated by either party on the anniversary date of the agreement, providing thirty days' notice has been given prior to such date.

Under the terms of the agreement, the Atmores will not use the water taken from Bear Canyon for human consumption and they waive

any right or claim to water service on the same basis as customers within the area served from the distribution system of the utility.

The agreement contains a provision that it shall, at all times, be subject to change or modification by this Commission in the exercise of its jurisdiction.

The application states that Santa Paula owns an appropriative right to water from Santa Paula Creek and that the premises of the Atmores are located above Santa Paula's distribution system.

The Commission having considered the request of applicant. and being of the opinion that the application should be granted and that a public hearing is not necessary; therefore,

IT IS HEREBY ORDERED that Santa Paula Water Works, Ltd., a corporation, be authorized to carry out the terms and conditions of the agreement with George M. Atmore and Helen M. Atmore, his wife, as set forth in Exhibit A attached to the application, which exhibit is made a part of this order by reference.

IT IS HEREBY FURTHER ORDERED that Santa Paula Water Works, Ltd., shall:

File with this Commission within thirty days after 1. the effective date of this order two certified copies of the agreement as executed together with a statement of the date on which the agreement is deemed to have become effective.

2. Notify this Commission of the date of termination of said agreement within thirty days from and after said date of termination.

The effective date of this order shall be twenty days after the date hereof.
