GH ORIGINAL 57162 Decision No. BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA In the Matter of the Application of UNION PACIFIC RAILROAD COMPANY, a corporation, for authority to Abandon 37 Non-Agency Stations in the State of Application No. 39894 California. OPINION By this application filed March 10, 1958, applicant, a common carrier of passengers and freight by railroad, seeks authority to abandon 37 nonagency stations in the State of California. This verified application discloses that no passengers or freight business has been transacted at any of these nonagency stations for the last two years. None of the stations named in the application has any station facilities nor any industry tracks nor any team tracks, with the exception of the station of Purex Spur where there is an industry spur track, the station of San Antonio Meat Co. Spur track where there is an industry spur track, and the station of Calada where there is a set-out track. The Commission finds, from the allegations of the verified complaint and from an informal investigation carried on by the Commission staff, that public convenience and necessity no longer require the maintenance of any of the stations named and numbered in the above-numbered application and consequently there is no further need that any of said stations continue to be listed in published station lists or in applicant's various freight and passenger tariffs. A public hearing is unnecessary. ORDER Application therefor having been filed and the Commission being fully advised in the premises, -1-

IT IS ORDERED:

(1) That Union Pacific Railroad Company is authorized to abandon its following named and numbered nonagency stations:

(2) That applicant is authorized to eliminate each of said station names and numbers from its station records, and to cancel all tariff and time schedules applying at each of said stations on not less than five days' notice to the Commission and to the public. Such tariff changes shall quote this decision as the requisite authority. This order shall not be construed as authorization to increase rates or charges.

(3) That within thirty days after abandonment is authorized herein, applicant shall so notify the Commission in writing. This authorization shall expire if not exercised within one year, unless time be extended.

The effective date of this order shall be twenty days after the date hereof.
