OPINION AND ORDER

Applicants, Vallejo Citizens Transit Co., a corporation, and a copartnership consisting of seven individuals doing business as Vallejo Transit Lines, presently rendering a passenger stage service within the City of Vallejo and areas adjacent thereto, request authority to extend three of their routes and further, authority to discontinue four schedules on two of their other routes.

Applicants propose to extend their Springs Road and Georgia Street Routes, a matter of several blocks in each instance. Neither will result in any appreciable increase in mileage and they assertedly will provide a service to many more individuals. The proposed extension of the Chabot Route will provide service to the new Vallejo Junior College. The extension will add 1.8 miles per trip to the total operation.

Applicants also propose the discontinuance of the two morning schedules (6:20 and 6:40 a.m.) and two evening schedules (6:20 and 6:35 p.m.) on their Vista and Beverly Hills Routes. A tabulation made by applicants and covering a period of seven weeks indicates that said schedules are very little used.

Copies of the application were served upon the City of Vallejo and the County of Solano. No protest has been received.

After consideration the Commission is of the opinion that public convenience and necessity require the granting of the authority sought. A public hearing is not necessary.

O R D E R

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED:

1. That First Revised Page 3, Second Revised Page 5 and First Revised Page 6 attached hereto and made a part hereof are hereby substituted in the place and stead of Original Page 3, First Revised Page 5 and Original Page 6 of Appendix A attached to Decision No. 52973 in Application No. 37959.

2. That applicants are hereby authorized to discontinue the schedules heretofore referred to.

3. That on not less than ten days' notice to the Commission and to the public applicants shall amend their tariffs and timetables presently on file with this Commission to reflect the authority herein granted.

The effective date of this order shall be twenty days after the date hereof.
