SUPPLEMENTAL OPINION AND ORDER

Minimum Rate Tariff No. 4-A provides minimum rates and rules for the transportation of used household goods and related articles between points in California. Item No. 90 thereof sets forth a provision for the alternative application of common carrier rates. For clarification, the item will be revised to specifically provide that a rate no lower than the common carrier rate and a weight no lower than the actual weight or published minimum weight applicable in connection with the common carrier rate shall be used. This clarification is in conformity with Informal Ruling No. 20 of the Commission's Transportation Division, issued October 19, 1956.

In addition, the tariff will be revised to provide specifically that accessorial charges may not be offset by transportation charges. This clarification is in conformity with Informal Ruling No. 35, issued February 20, 1958.

Therefore, good cause appearing,

IT IS ORDERED that Minimum Rate Tariff No. 4-A (Appendix "A" of Decision No. 44919, as amended) is hereby further amended by incorporating therein, to become effective September 12, 1958, Third Revised Page 2 and Fourth Revised Page 7, which revised pages are attached hereto and by this reference made a part hereof.
