He also holds a radial highway common carrier permit.

Due to financial and legal difficulties encountered in his business, Bealey has requested suspension of his certificates. He states that it is his desire to reopen his business as soon as he is able to straighten out his affairs. His radial highway common carrier permit has been suspended until July 25, 1959. In the circumstances, the certificates will also be suspended to July 25, 1959.

Applicant is hereby placed upon notice that he shall notify the Commission in writing at least thirty days prior to the

restoration of his operations if such restoration date is prior to the expiration of the suspension authorized herein and state the date he will commence operations.

Therefore, good cause appearing,

IT IS ORDERED:

(1) That the certificates of public convenience and necessity acquired by M. E. Bealey, doing business as Clipper Transport, by authority of Decision No. 54932, dated April 30, 1957, in Application No. 38738, and Decision No. 55492, dated August 27, 1957, in Application No. 39294, are hereby suspended to and including July 25, 1959.

(2) That Western Motor Tariff Bureau, Inc., is hereby authorized and directed to suspend until July 25, 1959, on not less than five days' notice, the participation of M. E. Bealey, doing business as Clipper Transport, from its tariffs on file with this Commission and that a copy of this order be forthwith served upon W. J. Knoell, Tariff Publishing Officer for Western Motor Tariff Bureau, Inc., Agent, as agent for M. E. Bealey as party to the aforesaid tariffs.

The effective date of this order shall be twenty days after the date hereof.
