ORDER

The Department of Public Works of the State of California, in connection with the improvement of State Route 19 (Eighth Street, Riverside), is authorized to construct five crossings at separated grades under tracks of Union Pacific Railroad Company, Southern Pacific Company, and The Atchison, Topeka and Santa Fe Railway Company, in the City of Riverside, Riverside County. Construction of the grade separations shall be at the locations described in Exhibit "A" and as shown on Exhibit "B" attached to the application as amended June 25, 1958, to be identified as follows:

During construction of the separation structures, Union Pacific Railroad Company and The Atchison, Topeka and Santa Fe Railway Company are authorized to construct temporary shooflies around the construction sites across Eighth Street and operate their trains thereover. Upon completion of the separation structures and restoration of tracks thereon, said shooflies shall be abandoned and removed.

Clearances for the separation structures and temporary shooflies shall conform with the provisions of General Order No. 26-D.

Construction and maintenance costs shall be borne in accordance with terms of an agreement to be entered into between the parties, and a copy of said agreement, together with plans of said structures approved by the railroads, shall be filed with the Commission prior to commencing construction. Should the parties fail to agree, the Commission shall apportion the cost of construction and maintenance by further order.

The foregoing authority is subject to the following condition:

Increased crossing protection shall be installed at Crossings Nos. 3-57.5, 2B-9.75, and BJ-546.1, as indicated on the attached Appendix "A", and in operation on or before inauguration of the proposed temporary State Route 19 detour on Seventh Street at tracks of Union Pacific Railroad Company, The Atchison, Topeka and Santa Fe Railway Company, and Southern Pacific Company.

Within thirty days after completion pursuant to this order, applicant shall so advise the Commission in writing. This authorization shall expire if not exercised within two years,

unless time be extended, or if above conditions are not complied with. Authorization may be revoked or modified if public convenience, necessity, or safety so require.

The effective date of this order shall be twenty days after the date hereof.
