O P I N I O N

Applicant requests authority to make a minor route change along its Route "3" - Mission Hills-Ocean View Boulevard line in order to comply with a street widening program along Washington Street in the City of San Diego. It is alleged that the city proposes to widen Washington Street from Hawk Street east to 5th Avenue and that the new traffic regulations will prevent the making of the present left turn at the intersection of Hawk Street and Washington Street. Applicant proposes, on eastbound trips, to turn left from Hawk Street to Fort Stockton Street, thence south on Goldfinch Street to Washington Street, thence along present route.

The public will not be materially inconvenienced. No change in fares, schedules, or equipment is contemplated. The application is not opposed.

The Commission finds that the proposed change is in the public interest and, therefore, the application will be granted. A public hearing is not deemed necessary.

O R D E R

Application having been made, the Commission being fully advised in the premises and finding that public convenience and necessity so require,

IT IS ORDERED that San Diego Transit System, a corporation, may reroute its Route "3" - Mission Hills-Ocean View Boulevard line, and Appendix A to Decision No. 55090 ⁽¹⁾ is hereby further amended by incorporating therein Second Revised Page 23 cancelling First Revised Page 23 of Appendix A attached hereto and made a part hereof.

Section 3. ROUTE DESCRIPTIONS (continued)

ROUTE "3" - MISSION HILLS-OCEAN VIEW BOULEVARD

From the intersection of Trias Street and Fort Stockton Drive, loop via Fort Stockton Drive, Arista Drive, Presidio Drive, and Trias Street to Fort Stockton Drive, thence via Fort Stockton Drive, Lewis Street, and Hawk Street to Fort Stockton Drive, thence eastbound only, via Fort Stockton Drive and Goldfinch Street to Washington Street, thence via Washington Street and 5th Avenue to Beech Street, thence westbound only via Beech Street, 4th Avenue, and Market Street to 5th Avenue, thence via Market Street, 25th Street, and Ocean View Boulevard to 40th Street.

Also, from the intersection of Goldfinch Street and Washington Street, westbound only via Washington Street and Hawk Street to Fort Stockton Drive.

Also, from the intersection of Market Street and 5th Avenue, northbound only via 5th Avenue to Beech Street.
