SECOND SUPPLEMENTAL OPINION AND ORDER

By Decision No. 55500, dated September 3, 1957, on Application No. 38440, Pacific Water Co. was granted authority to construct and operate a domestic water system in Tract No. 5259 as an extension of and to be connected with its Victorville No. 6 System in Lucerne Valley, subject to the condition "That Pacific shall not extend its water system outside of the boundaries of the tract herein certificated without further order of the Commission."

By Decision No. 56192, dated February 4, 1958, in Application No. 38440, First Supplemental, the service area was extended to include a tract of land 630.63 feet by 963 feet contiguous to Tract No. 5259.

By the Second Supplemental Application No. 38440, applicant seeks authority to extend service to Tracts Nos. 5817 and 5818 to the north and east of Tract No. 5259 and contiguous thereto, containing a total of 150 acres divided into a total of 189 lots, a 5-acre tract owned by Norman V. Unroe, a 5-acre tract owned by Dale Westergard, and a 5-acre tract owned by M. P. Kneifer. The latter

three parcels are west of and contiguous to Tract No. 5259. All are depicted on Exhibit A attached to the Second Supplemental application. Extensions will be made pursuant to applicant's filed rules for extensions to serve individuals or subdivisions.

The Commission's staff has investigated the proposal and recommends that the application be granted subject to two restrictions which will be incorporated in the order herein.

The above-entitled Second Supplemental application having been filed, the Commission having considered the matter and being of the opinion that the request should be granted, subject to the conditions contained in the order herein, and that a public hearing is not necessary,

IT IS HEREBY ORDERED:

That ordering paragraph (1) of Decision No. 55500, supra, as amended by ordering paragraph (2) of Decision No. 56192, supra, be and it is amended to read as follows:

Pacific Water Co., a corporation, be and it is granted a certificate of public convenience and necessity to acquire, construct and operate a public utility water system in Tract No. 5259, a parcel of land 630.63 feet by 963 feet lying west of Mesa Road, south of Lot 16, and north of Lots 17 and 18, Tract No. 5259, Tract No. 5817, Tract No. 5818, the Norman V. Unroe property, the Dale Westergard property, and the Kneifer property, the latter three properties being on the west of Tract No. 5259, all properties and tracts being in San Bernardino County.

IT IS HEREBY FURTHER ORDERED that the authority herein granted is subject to the following conditions:

(a) Pacific Water Co. shall complete the installation of all facilities ordered by Decision No. 55500, dated September 3, 1957, in Application No. 38440, prior to the construction of any facilities or the delivery of any water pursuant to the order herein.

(b) Pacific Water Co. shall not extend its water system beyond the area herein certificated without further order of this Commission.

Except as herein modified, Decision No. 55500, supra, as modified by Decision No. 56192, supra, shall remain in full force and effect.

The effective date of this order shall be twenty days after the date hereof.
