Minimum Rate Tariff No. 9-A gets forth minimum rates, rules and regulations for transportation performed within the San Diego Drayage Area. Item No. 10 thereof names certain holidays to be used in connection with various rates provided in the tariff. By this petition the California Trucking Associations, Inc. seeks the inclusion of Washington's Birthday and December 24 as holidays in that item.

The petition alleges that as a result of recent labor agreements, December 24 is now a day for which premium holiday wages must be paid. It also alleges that Washington's Birthday, though not included in the tariff, is included in the previous and current labor contracts as a holiday.

In the circumstances, it appears, and the Commission finds, that petitioner's proposal is justified. The petition will be granted. A public hearing is not necessary.
