## <u>O P I N I O N</u>

The Greyhound Corporation requests authority to operate over an additional urban route within the City of Oakland extending from the junction of Twentieth Street and Webster Street, over Webster Street to Thirteenth Street to East Twelfth Street.

Applicant alleges that the City of Oakland has recently adopted an ordinance by which motor vehicles moving between Webster Street and East Twelfth Street will be restricted to northbound vehicles only; that the proposed route would be used for corresponding southbound vehicles between the same points; that the proposed route has been approved by representatives of the traffic department of the City of Oakland.

After consideration the Commission is of the opinion and so finds that public convenience and necessity require the granting of the authority sought. A public hearing does not appear to be necessary.

## ORDER

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED that:

(1) A certificate of public convenience and necessity is hereby granted to The Greyhound Corporation, authorizing the establishment and operation of service as a passenger stage corporation,

as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in Route UR-7.10 appearing on Second Revised Page 73 of Appendix A, attached hereto, as an extension and enlargement of, consolidation with and subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.

(2) Appendix A of Decision No. 55893 is hereby amended by incorporating Second Revised Page 73.

(3) In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within sixty days after the effective date hereof and on not less than five days' notice to the Commission and to the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs and timetables satisfactory to the Commission.

The effective date of this order shall be twenty days after the date hereof.
