O P I N I O N

Ray Withers and Andrew Byrd, doing business as San Mateo Transit, presently rendering a passenger stage service between San Mateo, Burlingame, Hillsborough, Belmont, San Carlos, Redwood City, Menlo Park, Atherton, Palo Alto and East Palo Alto, request authority to provide a certificated service for the transportation of students and school employees of San Mateo College, Burlingame Elementary School District, Hillsborough School District, Notre Dame College and the San Mateo Elementary School District.

Public hearing was held before Examiner Thomas E. Daly on October 30, 1958, at San Mateo.

Applicants are presently providing school service under contractual arrangements. Contracts are awarded as the result of competitive bidding and are executed on an annual basis. Their present contracts provide for an hourly charge of \$9 an hour per unit of equipment. They propose to use their equipment interchangeably for their general and school services. Service would be provided on all school days.

Applicants contend that there is a certain doubt as to whether the proposed operations require a certificate. They are of the opinion that the granting of the certificate will remove the doubt and thereby assure the continuation of a needed service.

Protestant, herein, asked that the certificate be granted for the term of the contracts only.

After consideration the Commission is of the opinion and so finds that public convenience and necessity require the granting of the authority sought without restriction as to time.

#### O R D E R

Application having been filed and the Commission being informed in the premises:

#### IT IS ORDERED:

(1) That a certificate of public convenience and necessity is hereby granted to Ray Withers and Andrew Byrd, doing business as San Mateo Transit, authorizing the transportation of school children and school employees as a passenger stage corporation between the points and over the routes set forth on Original Pages 3 to 13, inclusive, which are attached hereto and are hereby added to Appendix A of Decision No. 56321.

(2) That ~~Third Revised~~ Page 2 attached hereto is hereby substituted in the place and stead of Second Revised Page 2 of Appendix A of Decision No. 56321.

(3) That in providing service to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.

- (b) Within sixty days after the effective date hereof and on not less than five days' notice to the Commission and to the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs and timetables satisfactory to the Commission.

The effective date of this order shall be twenty days after the date hereof.
