OPINION The Greyhound Corporation seeks authority to revise certain urban routes within the City of Stockton in order to conform to a recently adopted ordinance of that city which restricts directions of movement of traffic on streets over which applicant is presently authorized to operate. The application proposes that routes UR-17.02 and UR-17.04 be altered and that the former route UR-17.04 be re-established in part as route UR-17.09. The authority requested relates only to urban route authorization and does not propose any new service not presently authorized. No new fares or rates are involved. Frequency of service or the kind or number of units of equipment to be operated will not be affected. It appears that the routes of operation proposed in this request are the most feasible and practical routes to be adopted in conformity with the new ordinance. A public hearing does not appear to be necessary. No protest to this application has been received. After full consideration of the applicant's request, the Commission finds that public conven-

ience and necessity require that the application be granted.

## ORDER

Application having been made and the Commission being fully advised,

## IT IS ORDERED:

- 1. That Appendix A of Decision No. 55893 is hereby amended by incorporating First Revised Page 87 in revision of Original Page 87.
- 2. That the authority herein granted is an extension and enlargement of, and consolidation with and subject to, all the limitations and restrictions set forth in the certificate granted by Decision No. 55893.
- 3. That in providing service pursuant to the authority herein granted The Greyhound Corporation shall comply with and observe the following service regulations:
  - a. Within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and to the public, The Greyhound Corporation shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs and timetables satisfactory to the Commission.
  - b. Within thirty days after the effective date hereof, The Greyhound Corporation shall file with the Commission appropriate map or maps consistent with the authority granted by this order.
