## OPINION

Key System Transit Lines requests authority to extend its service over certain streets in the Cities of San Pablo and El Cerrito for the purpose of transporting school children attending Walter J. Helms Junior High School, Richmond Senior High School, Portola Junior High School, and the El Cerrito Senior High School.

As justification for the authority sought, applicant alleges that, due to the discontinuance of school bus transportation by the Richmond School District, it was called upon to operate additional and supplementary service for the school children.

Beninger Transportation Service, Inc., also operates over certain of the proposed streets. Therefore, appropriate restrictions will be imposed to prevent duplication of service.

After consideration the Commission is of the opinion and so finds that public convenience and necessity require the granting of the authority as hereinafter set forth. A public hearing is not necessary.

## ORDER

Application having been filed and the Commission being informed in the premises,

A-40682 GF IT IS ORDERED: That a certificate of public convenience and necessity is hereby granted to Key System Transit Lines authorizing the transportation of passengers over and along the following streets: San Pablo San Pablo Avenue - from 23rd Street to Broadway Broadway - from Road No. 20 to 17th Street Road No. 20 - from Broadway to Church Lane Church Lane - from Road No. 20 to San Pablo Avenue Castro Street - from Road No. 20 to Waterman Avenue Giant Highway - from John Street to Griffin Drive Griffin Drive - from Giant Highway to McGlothen Avenue McGlothen Avenue - from Griffin Drive to Williams Drive Williams Drive - from McGlothen Avenue to Collins Avenue Collins Avenue - from Griffin Drive to Giant Highway Waterman Avenue - from Castro Street to Broadway El Cerrito Moeser Lane - from San Pablo Avenue to Pomona Avenue Pomona Avenue - from Moeser Lane to Stockton Avenue Waldo Avenue - from San Pablo Avenue to Pomona Avenue Ashbury Avenue - from Moeser Lane to Central Avenue Central Avenue - from San Pablo Avenue to Ashbury Avenue That, within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted and, within sixty days after the effective date hereof and on not less than ten days' notice to the Commission and to the public, shall establish the service herein authorized and shall file, in triplicate, and concurrently make effective, tariffs and timetables satisfactory to the Commission. 3. That the authority granted in ordering paragraph 1 hereof is subject to the following conditions: (a) Passengers may be transported to or from Walter J. Helms Junior High School, but shall not be picked up or discharged along the following streets: San Pablo Avenue - from 23rd Street to Broadway Broadway - from Road No. 20 to 17th Street Road No. 20 - from Broadway to Church Lane Church Lane - from Road No. 20 to San Pablo Avenue Castro Street - from Road No. 20 to Waterman Avenue Waterman Avenue - from Castro Street to Broadway -2(b) Passengers to or from Walter J. Helms Junior High School shall have points of origin or points of destination north of Road No. 20.

The effective date of this order shall be twenty days after the date hereof.
