BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of MERRIFIELD TRUCKING COMPANY, a corporation, for a certificate of public convenience and necessity to operate as a highway common carrier: (a) of specifically named food products between certain presently authorized points, and (b) of specifically named food products between Sanger and Turlock and certain presently authorized points, as extensions of applicant's present services pursuant to Section 1063, Public Utilities Code.

<u>OPINION</u>

Merrifield Trucking Company, a corporation, applicant herein, now holds a certificate of public convenience and necessity authorizing it to transport commodities between various points, places and areas as more specifically set forth in Decisions Nos.

54285. 54792 and 54971. Generally, the authority is for (1) general commodities, between points in a described area consisting of portions of Santa Barbara, Ventura, Los Angeles, San Bernardino, Riverside and Orange Counties (hereinafter referred to as the Los Abgeles Area), (2) limited commodities such as foodstuffs, beverages, meats, poultry, lard, starch, et al., between the Los Angeles Area, on the one hand, and the San Francisco Territory and San Diego, on the other hand, and between the San Francisco Territory and San Diego, (3) sugar, between Carlton, Betteravia and Spreckels, on the one hand, and the Los Angeles Area, on the other hand, (4) citrus fruits and juice, fresh and frozen, between Tulare County and Goleta, on the one hand, and the Los Angeles Area, on the other hand, and (5) fruits, vegetables, cold pack or frozen, and citrus fruit, between Patterson, Ceres, Modesto, Fresno, Stockton and Bakersfield, on the one hand, and the Los Angeles Area, the San Francisco Territory, San Diego and Tulare County and Goleta, on the other hand. It is apparent from an examination of the said decisions that applicant's present operating authority is somewhat restricted and complex as to the commodities it may transport and points and places between which it may serve.

By this application authority is sought to increase present categories of commodities and to enlarge its present areas of service.

Public hearings were held in Los Angeles and San Francisco before Examiner Mark V. Chiesa. Oral and documentary evidence having been adduced, the matter was submitted subject to the filing of briefs since filed and considered.

The record shows that applicant and its predecessors have engaged in the transportation of food products and related commodities, shipped under temperature control and otherwise, for many years. Its present certificated authority was predicated generally upon the scope of its operations prior to September of 1953. Since then there has been a continued increase in population in the area served by applicant and a material expansion in number of items which are being shipped under temperature control, as well as related commodities not requiring temperature control.

Applicant operates in excess of 200 pieces of equipment, employs 160 persons, of which 110 are drivers, many with training in the operation of special temperature control equipment. Terminals are maintained at Los Angeles, Anaheim, Oakland and San Jose, and lesser station facilities are located at Modesto and Fresno. Applicant is financially sound and has been maintaining a position of leadership in the food transportation field in this State.

The food products and other commodities now sought to be added are in most instances shipped or received by companies manufacturing, processing, or dealing in commodities requiring temperature control. Thirty-nine shipper witnesses testified in support of the application. They represented large and small manufacturers, processors or distributors. The testimony shows that there is an increasing need for transportation of shipments requiring

temperature control equipment and also of mixed shipments consisting of related products or commodities not requiring temperature control. It was testified that it is especially desirable to have available a transportation service that would eliminate the necessity of using multiple carriers with the attendant shipping difficulties, inconveniences, and paper work. The record shows that a more complete service as herein proposed would be in the public interest.

Four protestants presented evidence of their operating authority, characteristics of present service, types of equipment, location of terminals, personnel, and financial condition. The objections in the main were to the expansion of applicant's present commodity list and to the enlargement of some of the service area. Applicant's proposed service is substantially a continuation of the kind and type of transportation which it is now authorized to perform, fitted to present business and transportation conditions. It is not apparent from the evidence that protestants would suffer any material loss of present business or revenue.

Having considered the evidence of record, the Commission is of the opinion and finds that public convenience and necessity require that applicant be authorized to enlarge its present operations so as to provide a more complete service for that portion of the public engaged in the production and distribution of food products and other related commodities as hereinbelow set forth.

For clarification, and to avert a multiplicity of certificates, the Commission deems it advisable to grant a new certificate of public convenience and necessity in lieu and stead of the existing certificates.

A public hearing having been held, the Commission being fully advised in the premises and having found that public convenience and necessity so require,

IT IS ORDERED:

A. 39732 - MP

(1) That a certificate of public convenience and necessity be, and it hereby is, granted to Merrifield Trucking Company, a corporation, authorizing it to operate as a highway common carrier, as defined by Section 213 of the Public Utilities Code, for the transportation of property between the points and over the routes as more particularly set forth in Appendices A, B and C, attached hereto and made a part hereof, and subject to the conditions and restrictions, if any, set forth therein.

(2) That, in providing service pursuant to the certificate herein granted, there shall be compliance with the following service regulations:

- a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 99. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 99, may result in a cancellation of the operating authority granted by this decision.
- b. Within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate and concurrently make effective tariffs and time schedules satisfactory to the Commission.

(3) That the operating authority herein granted is in lieu of all prior highway common carrier operating authority granted by this Commission to Merrifield Trucking Company, a corporation, in Decisions Nos. 54285, 54792 and 54971, and said decisions are hereby revoked effective concurrently with the establishment of service pursuant to the authority herein granted.

The effective date of this order shall be twenty days after the date hereof.

- (2) Automobiles, trucks and buses, viz .: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis; freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.
- (3) Livestock, viz.: bucks, bulls, calves, cattle, cows, dairy cattle, ewes, goats, hogs, horses, kids, lambs, oxen, pigs, sheep, sheep camp outfits, sows, steers, stags or swine.
- (4) Liquids, compressed gases, commodities in semiplastic form and commodities in suspension in liquids in bulk, in tank trucks, tank trailers, tank semitrailers or a combination of such highway vehicles.
- (5) Commodities when transported in bulk in dump trucks or in hopper-type trucks.
- (6) Commodities when transported in motor vehicles equipped for mechanical mixing in transit.
