Application of SAN DIEGO TRANSIT SYSTEM, a corporation, for authority to reroute its Route "T" - CROWN POINT line.

Application No. 40803

OPINION

Applicant proposes to establish a loop at the north end of Route "T" by operating via Turquoise Street, Cass Street, Sapphire Street, Mission Boulevard and Turquoise Street. It does not propose any alteration of fares, schedules, or equipment operated.

Route "T" presently loops at the north end via Turquoise Street, Bayard Street, Sapphire Street, Mission Boulevard, and Turquoise Street, which loop, being within a block contiguous to the terminal, is not described in the certificated route (Appendix A, Decision No. 55090). Recent new residential construction on Bayard Street between Turquoise Street and Sapphire Street has caused a considerable amount of on-street parking, and as Bayard Street is quite narrow, it creates an extremely hazardous condition for coaches making a left turn from Turquoise Street onto Bayard Street. Cass Street is considerably wider than Bayard Street, and the use thereof would be safer and more satisfactory. The public could not be inconvenienced as no passenger stops would be affected by the change.

The Commission finds that the proposed route change is in the public interest. The application will be granted. A public hearing is not deemed necessary.

ORDER

Application having been made, the Commission finding that public convenience and necessity so require,

IT IS ORDERED that San Diego Transit System, a corporation, may reroute its Route "T" - Crown Point line, and Appendix A of Decision No. 55090 is hereby further amended by incorporating therein Third Revised Page 18 of Appendix A attached hereto and made a part hereof.

Applicant shall, within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and to the public, amend its tariff and time schedule to reflect the authority herein granted.

The effective date of this order shall be the date bereof.
