Application of SAN DIEGO TRANSIT SYSTEM,
 a corporation, for authority to reroute
 its Route "13" - WESTGATE PARK SERVICE.

O P I N I O N

Applicant proposes to reroute that portion of its Route "13" - WESTGATE PARK service as now described in the second paragraph of Original Page 30A of Appendix A to Decision No. 55090 by operating southbound from 5th Avenue and Beech Street via Beech Street and 4th Avenue to Broadway. It does not propose any change in fares, schedules, or equipment operated.

By Decision No. 56494, dated April 8, 1958, applicant was granted authority to operate Route "13" in both directions on 5th Avenue between Broadway and Beech Street. However, as 5th Avenue is now a one-way northbound street from Ash Street south, applicant requests an amendment to its certificate providing for operation southbound via 5th Avenue, Beech Street, and 4th Avenue to Broadway. This proposed routing follows the routing of applicant's other routes which operate southbound on 5th Avenue.

The Commission finds that the proposed route changes are in the public interest and, therefore, the application will be granted. A public hearing is not deemed necessary.

O R D E R

Application having been made, the Commission finding that public convenience and necessity so require,

IT IS ORDERED that San Diego Transit System, a corporation, reroute its Route "13" - Westgate Park Service, and Appendix A of Decision No. 55090 is hereby further amended by incorporating therein First Revised Page 30A of Appendix A attached hereto and made a part hereof.

Applicant shall, within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and to the public, amend its tariff and time schedule to reflect the authority herein granted.

The effective date of this order shall be the date hereof.

Section 3. ROUTE DESCRIPTIONS (Continued)

ROUTE "13" - WESTGATE PARK

From the intersection of 3rd Avenue and Broadway, via Broadway, 11th Avenue, U. S. Highway No. 395, and Friars Road to Westgate Park.

Also, from the intersection of Broadway and 5th Avenue, northbound only via 5th Avenue to Beech Street, then via 5th Avenue, University Avenue, and 6th Street Expansion to U. S. Highway No. 395.

Also, from the intersection of 5th Avenue and Beech Street, westbound only via Beech Street and 4th Avenue to Broadway.
