OPINION

By Decision No. 56315, dated March 3, 1958, applicant was granted authority to transport persons (1) between Sam Pedro and the Los Angeles Coliseum, (2) between Long Beach and Marineland of the Pacific Oceanarium, and (3) between Long Beach, Los Alamitos Bay, Los Cerritos Ranch House and Pierpoint Landing. The service between Sam Pedro and the Los Angeles Coliseum was to be rendered only for persons desiring to attend Coliseum events and the services between Long Beach and other points as in parts (2) and (3) were to be rendered as a sightseeing service and only on a round-trip basis.

Applicant states that in filing the original application it was its intention to seek permission to render the proposed services on an "on-call" basis for a minimum of fifteen (15) adult round-trip fares, and that it did not discover until recently that such a provision was not included in the certificate which was issued. Applicant alleges that none of the said services can be profitably operated except on an "on-call" basis and requests that its certificate be amended to provide for such type of operation.

The Commission finds that the proposed change is in the public interest and the application will be granted. A public hearing is not deemed necessary.

ORDER

Application having been made, the Commission finding that public convenience and necessity so require,

IT IS ORDERED that Dominic A. Mannino, doing business as M & M Charter Lines, may operate its services as authorized by Decision No. 56315 on an "on-call" basis and Appendix B of said decision is hereby amended by incorporating therein First Revised Pages 1 and 2 of Appendix B attached hereto and made a part hereof.

Applicant shall, within sixty days after the effective date bereof, and on not less than five days' notice to the Commission and to the public, amend its tariffs and timetables to reflect the authority herein granted.

Dominic Mannino, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport persons (1) between Sam Pedro, on the one hand, and the Los Angeles Coliseum, on the other hand, (2) between Long Beach, on the one hand, and Marineland of the Pacific Oceanarium, on the other hand, and (3) between Long Beach, Los Alamitos Bay, Los Cerritos Ranch House and Pierpoint Landing, subject to the following conditions:

- a. Transportation herein authorized between San Pedro and the Los Angeles Coliseum shall be rendered only for persons desiring to attend Coliseum events.
- b. Transportation herein authorized between Long Beach and other points as in parts (2) and (3) hereinabove shall be rendered as a sightseeing service and only on a round-trip basis.
- c. Passengers shall be picked up or discharged in accordance with local traffic rules, at or near the intersections or points listed in the application.
- d. Service shall be operated "on call", for a minimum of fifteen (15) adult round-trip fares.
