## ORDER SUSPENDING OPERATIVE RIGHTS

Riccardo Tunzi, Elio Sartori and Sergio Sartori, a partnership, doing business as Salinas Valley Freight Lines, possess highway common carrier certificates authorizing the transportation of general commodities between points within the territory generally bounded by the San Francisco Bay Area on the north, and Salinas and King City on the south.

The liability insurance policy of Riccardo Tunzi, Elio Sartori and Sergio Sartori lapsed as of December 31, 1958. Evidence of liability protection required by General Order No. 100A not being on file, and the Commission being of the opinion and finding that such failure constitutes good cause for suspension of such certificate and of tariffs applicable to service thereunder,

IT IS ORDERED as follows:

(1) The certificates of public convenience and necessity to operate as a highway common carrier granted to Riccardo Tunzi, Elio Sartori and Sergio Sartori, a partnership, by Decision No. 52887, dated April 17, 1956, in Application No. 37879, are suspended pending further order.

(2) All tariffs issued by or on behalf of Riccardo Tunzi, Elio Sartori and Sergio Sartori, a partnership, are suspended pending further order. A copy of this order shall be filed with said tariffs in the office of the Commission.

The Secretary is directed to cause service of a certified copy of this order to be made upon Riccardo Tunzi, Elio Sartori and Sergio Sartori, a partnership, and a copy of this order to be mailed to Western Classification Committee, Agent, A. H. Glickman, Agent, and Western Motor Tariff Bureau, Agent.

The effective date of this order shall be the fifth day after such service, unless before such date, Riccardo Tunzi, Elio Sartori and Sergio Sartori, a partnership, shall have filed with this Commission evidence of insurance protection as required by General Order No. 100A, in which event the effective date of this order shall be stayed until further order of the Commission.
