THIRD SUPPLEMENTAL ORDER AMENDING DECISION NO. 54280

Planada Water Company, by Decision No. 55184, dated June 25, 1957, and by Decision No. 56877, dated June 24, 1958, was granted authority to extend the expiration date of its Schedule No. 2LX, Limited Temporary Business Flat Rate Service, from June 30, 1957 to June 30, 1959. Schedule No. 2LX was originally filed by the utility in compliance with Decision No. 54280, dated December 18, 1956, in this application.

By petition filed May 19, 1959, the utility alleges that during the past year unexpected maintenance expenses have prevented it from accumulating sufficient funds to purchase and install the meters required before the business flat rate service may be discontinued. The utility estimates the cost of purchasing and installing the required meters will be approximately \$3,000, and states that it expects to borrow the necessary funds by January 1, 1960. The utility therefore requests additional time to continue the furnishing of service under Schedule No. 2LX.

It appearing to the Commission that the petition should be granted; therefore,

IT IS HEREBY ORDERED that paragraph 2 of special conditions in Schedule No. 2LX, Limited Temporary Business Flat Rate Service,

annexed to Decision No. 54280 herein, as amended by Decision No. 55184 and Decision No. 56877, be and it hereby is further amended to read as follows:

"2. This schedule will be effective only to and including June 30, 1960, and will be withdrawn on July 1, 1960."

IT IS HEREBY FURTHER ORDERED that Planada Water Company is directed to file in quadruplicate with this Commission after the effective date of this order and in conformity with General Order No. 96 its Schedule No. 2LX, Limited Temporary Business Flat Rate Service, revised as indicated hereinabove and, upon not less than one day's notice to the Commission and to the public, to make such schedule effective for service rendered on or after July 1, 1959.

In order that the effectiveness of the subject schedule may be extended beyond its present June 30, 1959 termination date without interruption, the effective date of this order shall be five days after the date hereof.
