## ORDER GRANTING TEMPORARY INTERIM RELIEF

CECIL E. WILLIAMS, president and general manager of complainant corporation, 3671 East Colorado Boulevard, Pasadena, California, one of the complainants in the above-entitled case, having filed a verified complaint, alleging in substance that prior to July 7, 1959, complainant Cewil, Inc., a California corporation, was a subscriber and user of telephone service furnished by defendant under number SYcamore 3-3998 in a cafe owned and operated by complainant corporation at the above address; that on or about July 2, 1959, at said address, the Los Angeles Sheriff's Department arrested an employee of complainant corporation, who was not on duty at said time, on a charge of suspicion of bookmaking; that on or about July 7, 1959, the said telephone facilities of complainant corporation were disconnected by defendant; that complainant had never engaged in bookmaking, nor to the knowledge of complainant or with complainant's permission had said premises ever been so used, nor had any employees of complainant or others to the knowledge or with the permission of complainants over engaged in bookmaking at said address; that complainant advised said employees that any employee would be discharged if the phone was so used; that complainant corporation has suffered and will suffer irreparable injury to the business conducted at said address and great hardship as a result of being deprived of said telophone facilities.

IT IS ORDERED that The Pacific Telephone and Telegraph Company is hereby directed to restore telephone service to complainant corporation pending hearing on said complaint and further Commission order thereon, said service to be furnished pursuant to defendant's filed tariff rates and rules applicable thereto. The complaint will be set for hearing before such Commissioner or Examiner, and at such time and place, as may hereafter be designated.
