ORDER MODIFYING DECISION

It having come to the attention of the Commission that certain essential provisions had inadvertently been omitted from the rate schedule authorized by Decision No. 58877, dated August 11, 1959, in Application No. 40887; therefore, good cause appearing,

IT IS HEREBY ORDERED that Schedule No. 1, Annual General Metered Service, and Schedule No. 2R, Annual Residential Flat Rate Service, authorized by said Decision No. 58877 to be made effective by Ernest E. Hansen, an individual, doing business as Meadowbrook Water Association, are hereby superseded, respectively, by Schedule No. 1RL, Annual Restricted Residential Metered Service, and Schedule No. 2RL, Annual Restricted Residential Flat Rate Service, attached to this order as Appendix A.

In all other respects Decision No. 58877 shall remain in full force and effect.

The effective date of this order shall be the date on which said Decision No. 58877 shall become effective.

Schedule No. IRL

ANNUAL RESTRICTED RESIDENTIAL METERED SERVICEAPPLICABILITY

Applicable to all metered water service furnished on an annual basis for household residential purposes only.

TERRITORY

The unincorporated area known as Meadowbrook Woods, located approximately two miles south of Lake Arrowhead, comprising the entire N $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 28, Township 2 North, Range 3 West, San Bernardino Base & Meridian, San Bernardino County.

RATES

Per Meter
Per Year

Annual Quantity Rates:

First 4,000 cu.ft. or less	\$ 66.00
Next 2,000 cu.ft., per 100 cu.ft.	1.00
Over 6,000 cu.ft., per 100 cu.ft.65

Annual Minimum Charge:

For 5/8 x 3/4-inch meter	\$ 66.00
For 3/4-inch meter	90.00
For 1-inch meter	110.00

The Annual Minimum Charge will entitle the customer to the quantity of water which that minimum charge will purchase at the Annual Quantity Rates.

SPECIAL CONDITIONS

1. The annual minimum charge applies to service during the 12-month period commencing May 1, and is due in advance.

2. When the annual minimum charge is paid in advance, charges for water used in excess of the allowance under the annual minimum charge may be billed monthly, bimonthly or quarterly at the option of the utility.

Schedule No. 2RL

ANNUAL RESTRICTED RESIDENTIAL FLAT RATE SERVICE

APPLICABILITY

Applicable to all water service furnished on an annual flat rate basis for household residential purposes only.

TERRITORY

The unincorporated area known as Meadowbrook Woods, located approximately two miles south of Lake Arrowhead, comprising the entire NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 28, Township 2 North, Range 3 West, San Bernardino Base & Meridian, San Bernardino County.

RATE

	<u>Per Service Connection</u> <u>Per Year</u>
For each single family residence including premises	\$66.00

SPECIAL CONDITIONS

1. The annual flat rate charge applies to service during the 12-month period commencing May 1 and is due in advance.
2. All service not covered by the above classification will be furnished on a metered basis.
3. Meters may be installed at option of utility or customer for above classification in which event service thereafter will be furnished only on the basis of Schedule No. 1RL, Annual Restricted Residential Metered Service.
