IT IS FURTHER ORDERED that applicant is authorized to file in quadruplicate with this Commission, after the effective date of this order and in conformity with the provisions of General Order No. 96, the amended rate schedule attached to this order as Appendix A and, on not less than one day's notice to this Commission and to

Schedule No. 1

## GENERAL METERED SERVICE

### APPLICABILITY

Applicable to all metered water service.

### TERRITORY

Portions of the cities of Los Altos, Mountain View and Palo Alto, and adjacent unincorporated territory, Santa Clara County.

#### RATES

Per Meter Per Month Quantity Rates: First 600 cu.ft. or less ..... \$ 2.75 Next 2,400 cu.ft., per 100 cu.ft.... -36 Over 3,000 cu.ft., per 100 cu.ft..... .24 Minimum' Charge: For  $5/8 \ge 3/4$ -inch meter .... \$ 2.75 3/4-inch meter ..... For 4.00 For 1-inch meter ..... 6.00 1-1/2-inch meter ..... For 10.00 2-inch meter ..... For 15.00 3-inch meter ..... For 30.00

The Minimum Charge will entitle the customer to the quantity of water which that minimum charge will purchase at the Quantity Rates.
