By this application filed July 30, 1959, Key System Transit Lines requests an order which will enable it to place on a permanent basis the trial service operated during the 1958 Football Season of providing direct transportation between the University of California Stadium and San Francisco of passengers to and from the football games. The City of Berkeley has approved this application.

As stated in a recent decision granting this applicant authority to comply with City of Berkeley one-way street traffic changes, the only method by which relief can be granted is by issuing a new certificate of public convenience and necessity over designated city streets for short distances. This will be done but applicant is again reminded of the urgent necessity for clarifying its operative rights.

Considering the allegations of this Application No. 41357, the Commission is of the opinion and finds that public convenience and necessity require the issuance of the following authority. A public hearing does not appear to be required.

Application therefor having been filed and based upon the findings in the above opinion,

IT IS ORDERED:

1. That a certificate of public convenience and necessity is granted to Key System Transit Lines authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers between the points in the City of Berkeley as hereinafter stated as an extension and enlargement of and to be consolidated with its present passenger stage operations serving all intermediate points.

2. That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- b. Within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and the public, applicant shall establish the service herein authorized and shall file in triplicate and concurrently make effective, tariffs and time schedules satisfactory to the Commission.
- c. Subject to the authority of this Commission to change or modify them by further order, applicant shall conduct operations pursuant to the certificate herein granted between the points and along the public streets as follows:
 - 1. Over and along Durant Avenue between College Avenue and Piedmont Avenue.
 - 2. Over and along Piedmont Avenue and Gayley Road between Durant Avenue and Hearst Avenue.
 - 3. Over and along Hearst Avenue between Gayley Road and Euclid Avenue.

4. Over and along Hearst Avenue between Oxford Avenue and Sacramento Street.
