ORDER ENLARGING SCOPE  
OF INVESTIGATION AND DISMISSING PETITIONS

By Petition for Modification No. 37 in Case No. 5441, California Trucking Associations, Inc., has requested that the Commission enlarge the scope of this proceeding to include the additional Counties of Lake and Mendocino; that it direct its staff to review, and revise as indicated by current conditions, staff studies previously presented in connection with the Commission's order setting hearing dated February 15, 1955; and that immediately thereafter the Commission set such matter for hearing to receive evidence of its staff and of other interested parties.

The scope of the proceeding will be enlarged as requested. When revised staff studies or the evidence of other interested parties is ready for presentation, hearings will be scheduled. Meanwhile, in order to clear the Commission's formal docket, the investigation embraced by the aforesaid order setting hearing dated February 15, 1955, will be discontinued; and the following order will also dismiss Petition for Modification No. 16 herein which related to a phase of the same subject matter, and Petition for

Modification No. 37 which has in effect been granted by the order herein.

Therefore, good cause appearing,

IT IS ORDERED that:

1. The first ordering paragraph of the order instituting investigation dated January 27, 1953, as amended, in this proceeding is hereby further amended by substituting for the phrase "City and County of San Francisco and the Counties of Alameda, Contra Costa, Marin, Monterey, Napa, Santa Clara, Santa Cruz, San Benito, San Mateo, Solano and Sonoma," the phrase "City and County of San Francisco and the Counties of Alameda, Contra Costa, Lake, Marin, Mendocino, Monterey, Napa, San Benito, San Mateo, Santa Clara, Santa Cruz, Solano and Sonoma."

2. The investigation in that phase of Case No. 5441 embraced by the Commission's order setting hearing, dated February 15, 1955, be and it is hereby discontinued;

3. Petitions for Modification Nos. 16 and 37 in Case No. 5441 be and they are hereby dismissed.

The effective date of this order shall be twenty days after the date hereof.
