OPINION Capitol Transportation Co., presently rendering a passenger stage service between Sacramento and Sacramento Municipal Airport and within a one-mile radius of the Senator Hotel, requests authority to extend service to the Hotel El Rancho in West Sacramento. It is alleged that applicant renders service for all scheduled flights of the United Air Lines and the Pacific Air Lines landing in Sacramento; that said flights approximate thirty-six in number; that many of the passengers of these flights, including flight personnel, are quartered at the Hotel El Rancho which is located 2-1/2 miles from the Senator Hotel. After consideration, the Commission is of the opinion that public convenience and necessity require the granting of the authority sought. A public hearing is not necessary. ORDER Application having been filed and the Commission being informed in the premises, IT IS ORDERED: 1. That in the place and stead of its existing operative rights, a certificate of public convenience and necessity is hereby granted to Capitol Transportation Co., authorizing the transportation -1.

A-41616 DR of passengers as a passenger stage corporation between the points and over the routes as set forth in Appendix A attached hereto.

- That, in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:
  - (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 98.
    Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 98, may result in a cancellation of the operating authority granted by this decision.
  - Within sixty days after the effective date hereof, (b) and on not less than ten days' notice to the Commission and to the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs and timetables satisfactory to the Commission.
- That the operating authority granted by Decision No. 51578, dated June 9, 1955 in Application No. 37001, is hereby revoked, said revocation to become effective concurrently with the effective date of the tariff filings required by paragraph 2(b) hereof.

The effective date of this order shall be twenty days after the date hereof.

## CAPITOL TRANSPORTATION CO. (a corporation)

Capitol Transportation Co., by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport airline passengers, persons accompanying airline passengers, airline and airport employees, baggage and shipments of express weighing 200 pounds or less, on passenger-carrying vehicles only, between West Sacramento, Sacramento, and Sacramento.

Municipal Airport over the following routes:

## Inbound Route

Beginning at Sacramento Municipal Airport, thence over Freeport Boulevard, Broadway, 16th Street, K Street, 12th Street to Senator Hotel, thence via L Street, 13th Street, K Street, 3rd Street, Capitol Avenue, West Capitol Avenue to Hotel El Rancho in West Sacramento; also within a one-mile radius from the Senator Hotel.

## Outbound Route

Beginning at Hotel El Rancho in West Sacramento, thence over West Capitol Avenue, West Sacramento Freeway, Capitol Avenue, 5th Street, J Street, 12th Street, to Senator Hotel, thence via L Street, 15th Street, Broadway, Freeport Boulevard to Sacramento Municipal Airport; also within a one-mile radius from the Senator Hotel.

Applicant is authorized to turn its motor vehicles at intersections or intermediate points, either in the intersection of the streets or by operating around a block contiguous to such intersection in either direction as traffic requirements of the municipality may require.
