This application was filed to seek the Commission's authorization for transfer of a partnership interest in a warehouse business in Esparto, California. The operating authority involved was created by Decision No. 58827, dated July 28, 1959, in Application No. 41247.

It is proposed that Edith A. Mast be authorized to transfer her partnership interest to Lowell E. Mast, who, with the three remaining partners will continue to operate the business. The consideration proposed is \$5,500.

After consideration the Commission is of the opinion and so finds that the proposed transfer will not be adverse to the public interest. A public hearing is not necessary.

The authorization herein granted shall not be construed as a finding of the value of the rights and equipment nor as a

determination that the amounts referred to herein will be accepted as proper bases for an order authorizing the issue of securities.

Application having been filed and the Commission being of the opinion that the application should be granted,

IT IS ORDERED:

1. That on or before February 1, 1960, Edith A. Mast may sell and transfer, and Lowell E. Mast may purchase and acquire, the operative rights and property referred to in the application.

2. That within thirty days after the consummation of the transfer herein authorized, Lowell E. Mast, Mary Grace Mast Richey, Jack D. Mast and Calvin Cowles Mast shall notify the Commission, in writing, of that fact and within said period shall file with the Commission a true copy of any bill of sale or other instrument of transfer which may be executed to effect said transfer.

3. That on not less than five days' notice to the Commission and to the public, effective concurrently with the consummation of such transfer, applicants shall amend or reissue the tariffs on file with the Commission, naming rates, rules and regulations governing the operations here involved to show that Lowell E. Mast, Edith A. Mast, Mary Grace Mast Richey, Jack D. Mast and Calvin Cowles Mast have withdrawn or canceled, and Lowell E. Mast, Mary Grace Mast Richey, Jack D. Mast and Calvin Cowles Mast have adopted or established as their own, said rates, rules and regulations. The

tariff filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 61.

The effective date of this order shall be twenty days after the date hereof.
