ORDER AMENDING DECISION NO. 59329
AND DENYING PETITION FOR REHEARING

Upon fully considering the Petition for Rehearing of the Tahoe Southside Water Utility in the above-entitled proceeding and upon further consideration of Decision No. 59329, the Commission is of the opinion that the aforesaid decision should be amended so as to authorize Tahoe Southside Water Utility to file in quadruplicate with this Commission, after the effective date of this order and in conformance with the provisions of General Order No. 96, the attached revised rate schedule "Appendix A Pages 3 and 4 of 6 Schedule No. 2S SEASONAL FLAT RATE SERVICE" which revised schedule authorizes additionally a faucet charge of \$2.50 for each outdoor 3/4-inch faucet during the summer season only, and on not less than five days' notice to this Commission and to the public to make such rates effective for all service rendered on and after February 1, 1960.

Tahoe Southside Water Utility is further authorized to file in quadruplicate with this Commission, after the effective date of this order and in conformance with the provisions of General Order No. 96, the schedules of rates attached to the order in Decision No. 59329 as Appendix A as modified herein, and on not less than five days' notice to this Commission and to the public to make said rates

effective for all service rendered on and after February 1, 1960.

Good cause appearing IT IS ORDERED that the Petition by Tahoe Southside Water Utility for Rehearing of Decision No. 59329, as amended herein, is hereby denied.

SPECIAL CONDITIONS

1. All service not covered by the above classifications will be furnished only on a metered basis.
2. Meters may be installed at the option of the utility only for the above classifications in which event service will thereafter be furnished on the basis of Schedule No. 1S, Seasonal Metered Service.
3. Except as otherwise specifically provided, service may be taken under this schedule for either the summer season, May 1 through October 31, or the winter season, November 1 through April 30, or both seasons.
4. The seasonal flat rate charge is payable in advance on or before the initial day of the season.
