ORDER MODIFYING DECISION NO. 57171

On November 25, 1959, The Pacific Telephone and Telegraph Company directed a letter to the Commission indicating that Decision No. 57171, among other things, relieved it of the responsibility of furnishing certain toll station service in the Wrightwood area coincident with the establishment of the Wrightwood exchange by California Interstate Telephone Company. The toll stations listed to be transferred correspond to the toll stations indicated in Exhibit D attached to Application No. 39569 of California Interstate Telephone Company and did not include toll stations designated Cajon No. 1 through No. 7, respectively, and Mile High No. 1.

At the hearing on July 17, 1958, in Wrightwood, California Interstate Telephone Company submitted a revised Exhibit D which was received in evidence<sup>1/</sup> as Exhibit No. 3 in Application No. 39569 excluding toll stations Cajon No. 1 through 6, respectively, and Summit Lookout from the transfer.

By letter dated December 24, 1959, California Interstate Telephone Company requested modification of Decision No. 57171 so

that the wording will correspond to its Exhibit No. 3. Applicants are proceeding to transfer the property in accordance with Exhibit No. 3 (Revised Exhibit D) and it appears to the Commission that Decision No. 57171 should be modified accordingly; therefore,

IT IS ORDERED that Decision No. 57171 be modified as follows:

1. In the first paragraph on Page 1, after the word application in the next to last line of said paragraph, insert: "revised to the extent shown in Revised Exhibit D introduced into the record by California Interstate Telephone Company as Exhibit No. 3 on July 17, 1958."

2. On Page 2 in the last line of the paragraph entitled The Wrightwood Area: change the figure "60" to "63".

3. On Page 4 under Tariff Changes, substitute the revised list of stations as shown in Section A of Revised Exhibit D introduced as Exhibit 3 as follows:

4. Also under Tariff Changes, on Page 4, substitute the revised list of stations as shown in Section B of Revised Exhibit D, as follows:






5. On Page 5 under Findings and Conclusions, change the figure "52" to "56" toll stations and the figure "8" to "7" toll stations.

In all other respects Decision No. 57171 shall remain in full force and effect.
