FIRST SUPPLEMENTAL ORDER

The Commission's order of its Decision No. 58885, dated August 18, 1959, in the above entitled case deals with the matter of the 1957 amendment to the Vehicle Code sections 576 and 576.5 (since codified as Section 22452) relating to the requirement for stops by certain motor vehicles at industrial or spur track railway crossings. The order, among other things, revoked the decisions by which certain crossings listed therein had been authorized as "exempt", and also prescribed a list of industrial or spur track crossings at which the installation of "exempt" signs is required, designated as Appendix "B" attached thereto and made a part thereof.

It has now developed that certain changes, corrections, deletions and additions should be made in this order; therefore,

Good cause appearing IT IS HEREBY ORDERED that the following changes, corrections, deletions and additions to the order, set out in the appendix attached hereto be made a part of Decision No. 58885.

The Secretary shall cause a copy of this order to be served by mail upon each and every railroad, passenger stage corporation, petroleum irregular route carrier, petroleum contract carrier and highway common carrier having authority to transport

petroleum products in bulk in tank vehicles, subject to the jurisdiction of this Commission.

The effective date of this order shall be five days after the date hereof.
