#### SUPPLEMENTAL ORDER

Appendix A of Decision No. 59427 incorrectly makes reference to authority to transport passengers as a <u>highway common</u> <u>carrier</u>. To correct this error and to clarify applicant's operative authority, an in-lieu certificate will be issued.

Good cause appearing,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity be, and it hereby is, granted to H. A. Shelley, doing business as Wilmington Bus Company, authorizing the transportation of persons as a "passenger stage corporation" as defined in Section 226 of the Public Utilities Code, between the points and over the routes as more particularly set forth in Appendix A attached hereto and made a part hereof, and subject to the conditions and restrictions as set forth in said Appendix A.

(2) That the certificate of public convenience and necessity granted in paragraph (1) of this order is in lieu of and supersedes all existing certificates of public convenience and necessity or other passenger stage operating authority heretofore granted to H. A. Shelley, doing business as Wilmington Bus Company, which

certificates and operating authority are hereby canceled and revoked.

(3) That H. A. Shelley, doing business as Wilmington Bus Company, shall continue to operate service as heretofore authorized and comply with the following service regulations:

> Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed upon notice that he will be required, among other things, to file annual reports of his operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 98. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 98, may result in a cancellation of the operating authority granted by this decision.

Section 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS, AND SPECIFICATIONS.

The certificate hereinafter noted supersedes all operative authority heretofore granted to H. A. Shelley, doing business as Wilmington Bus Company.

E. A. Shelley, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport passengers in the Wilmington area of the City of Los Angeles and the territory adjacent thereto, serving intermediate points along the routes as hereinafter described, subject to the following conditions:

- (a) Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, or in accordance with local traffic rules.
- (b) When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- (c) The authority to operate school service between the Stephen White Junior High School located at 22102 South Figueroa Street, Torrance, and points and places within the authorized area shall be limited to the transportation of school children and school employees destined to or originating at said school, and service shall be operated only on regular school days.

## PASADENA TOURNAMENT OF ROSES PARADE AND PASADENA ROSE BOWL SERVICE

Over and along the most appropriate, convenient, and direct route between Manhattan Beach, Hermosa Beach, Redondo Beach, Palos Verdes, Rolling Hills, Lomita Miraleste, San Pedro, Harbor City, and Wilmington, on the one hand; and the Pasadena Tournament of Roses Parade and the Pasadena Rose Bowl, on the other hand.

#### Restriction:

Service shall be limited to the transportation of round-trip passengers destined to the Pasadena Tournament of Roses Parade and/or the Pasadena Rose Bowl, and shall be provided on January 1 of each year only.
