In the Matter of the Application of BLANKENSHIP MOTORS, a corporation, for a certificate of public convenience and necessity to operate as a highway common carrier for the transportation of property.

Application No. 41390

OPINION

Blankenship Motors presently conducts the following highway common carrier operations:

- (1) Transportation of general commodities for mail order houses and their retail stores between designated points, covering a substantial part of the state.
- (2) Transportation of special commodities to, from and between points on designated highways between the San Francisco Bay Area, on the north, and San Diego and Los Angeles Basin, on the south.

Applicant requests authority to extend its service for mail order houses to additional points and to remove the special commodity restriction.

A public hearing was held before Examiner Thomas E. Daly on January 21, 1960, at Los Angeles. No appearance was made in protest to the authority sought.

Applicant owns and operates 227 pieces of equipment. It maintains terminals in San Leandro, Los Angeles, and Fresno. If the application is granted applicant proposes to establish additional terminals at Sacramento, San Diego, Santa Barbara, Santa María and Paso Robles. For the eleven months ending November 30, 1959, applicant indicated a net profit of \$24,747.24 after allowing for federal income taxes.

A. 41390 It was alleged by applicant that since the date when applicant was authorized to serve mail order houses, many of such establishments have either opened new stores or have plans to open new stores at the proposed extended points. With respect to applicant's requested authority to transport general commodities, applicant alleged that many of applicant's shippers, through lack of knowledge, tender to applicant commodities which it is not authorized to transport and that it is almost impossible to train applicant's pickup drivers to know the commodities it may and may not transport. It was alleged that this problem is further aggravated by the fact that some of the items included in applicant's operating authority cannot be rated without reference to Minimum Rate Tariff No. 2 or the Western Classification. Applicant was prepared to introduce the testimony of forty-nine public witnesses. In the absence of protest, however, and as a matter of convenience to these people they were not personally called. Instead their names, their company's name and location, commodities handled and shipping points were placed upon a list and received as late filed Exhibit No. 11. It was stated that if called these individuals would have testified as follows: (1) That their company's business has increased in past years. That their dock space is crowded and they would prefer to use a carrier with a wider territorial coverage. That there are complaints concerning the service of existing carriers. That they have split deliveries that cannot be handled on the most reasonable basis where applicant is a permitted carrier to some points and a common carrier to other points. (5) That applicant can handle part of their commodities as a common carrier between San Francisco and Los Angeles Territories -2A. 41390 but cannot handle to the intermediate points as a common carrier. That applicant can handle only part of such shippers' commodities as a common carrier. After consideration the Commission is of the opinion, and so finds, that public convenience and necessity require the granting of the authority sought. ORDER Application having been filed and the Commission being informed in the premises, IT IS ORDERED: That in lieu of its existing operative rights a certificate of public convenience and necessity is hereby granted to Blankenship Motors, authorizing the transportation of property as a highway common carrier between the points and over the routes set forth in Appendices A, B, C and D attached hereto. 2. That concurrent with the inauguration of service authorized in ordering paragraph 1 hereof the following operative rights are hereby revoked: Decision No. Dated Application No. 57834 39785 Jan. 6, 1959 Sept.15, 1959 Oct.27, 1953 Oct.16, 1956 June 26, 1956 58994 39785 49247 32047 53938 35553 53310 35553 That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations: Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations -3of the Commission's General Order No. 99. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 99, may result in a cancellation of the operating authority granted by this decision.

b. Within sixty days after the effective date hereof, and on not less than ten days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate and concurrently make effective, tariffs satisfactory to the Commission.

The effective date of this order shall be twenty days after the date hereof.

- (h) Between points in the San Francisco Territory, as described in Appendix B hereto attached.
- (i) Service is authorized to and from points laterally within twenty-five miles of points authorized to be served on the above-described routes.
- (j) Traversing any and all public highways, streets and roads between all points above authorized for operating convenience.

The authority granted in Paragraph B above is subject to the following condition:

Applicant shall not render service between points in San Francisco Territory on the one hand and points between San Jose and Soledad inclusive, on the other hand.

The authority above is subject to the following condition:

Applicant shall not transport commodities which have been sold at retail by a retail merchant, and transported from a retail store or retail store warehouse to residences of retail customers, or transported from residences of retail customers to retail stores or retail store warehouses, and such transportation is performed in vehicles in the exclusive use of the retailer and providing no shipment exceeds 2,000 pounds in weight. Further, that the merchandise is for the use or consumption of retail customers and is not for use in the furtherance of an industrial or commercial enterprise; and provided that the retailer shall certify on the shipping document for each delivery that the merchandise was sold at retail to a retail customer.
