OPINION AND ORDER The Pacific Telephone and Telegraph Company, in this application filed September 29, 1959, seeks authorization to establish extended service between its Pinole and Richmond exchanges. Public hearing in this matter was held at Pinole before Examiner James F. Haley on December 4, 1959.

Pinole is located about seven miles northeast from the downtown area of Richmond. Applicant serves both Pinole and Richmond by means of dial central office equipment. Toll charges now apply to calls between the two exchanges. Much of the growth in both exchanges has occurred in sections where the two exchanges have common boundaries.

Applicant states that it has received many requests from Pinole civic leaders, organizations and individuals for toll-free

calling to Richmond. An analysis of the toll usage of telephone subscribers shows that during a typical month Pinole subscribers placed 9,900 messages to Richmond, and Richmond subscribers completed 10,800 messages to Pinole. As of October 31, 1959, Richmond had over 50,000 stations and Pinole had 2,000 stations. Of the latter, over 600 were Richmond foreign exchange services.

Applicant's witnesses testified that establishment of the proposed extended service would result in an annual reduction in operating costs of \$29,600. They further testified that charges to Richmond and Pinole subscribers would be reduced by \$29,700 with the elimination of toll charges between the two exchanges and the establishment of applicant's proposed schedule of rates. Under applicant's proposal, Richmond exchange service rates would not be changed. The present and proposed rates for principal classes of service in Pinole exchange are as follows:

Representatives appeared in favor of the proposed extended service on behalf of the City of Richmond, Richmond Chamber of Commerce, City of Pinole and Pinole Lions Club. Three public witnesses expressed desire for consolidation of the two exchanges in preference to extended service. However, applicant proposes to continue to offer Richmond foreign exchange service in Pinole, and the Commission

A witness for the City of Pinole recommended the establishment of Pinole business message rate service. Applicant does not propose to offer such service. The Commission, however, is of the opinion that the offering of business message rate service in Pinole would be more reasonable than the offering of business flat rate service in view of the fact that only business message rate service is offered in the Richmond exchange. Applicant's rate witness suggested that the Richmond rate level would be appropriate for Pinole business message rate service under the proposed extended service arrangement. The order herein will provide that applicant shall offer Pinole business message rate individual line and PBX trunk service at the suggested rate level rather than business flat rate individual line, two-party line and PBX trunk service in that exchange.

Based upon the record, the Commission finds and concludes that the establishment of extended service between Richmond and Pinole and the elimination of toll charges between the two exchanges would be in the public interest. Except as hereinabove found with respect to Pinole business service, the Commission finds that the specific proposal of applicant is reasonable. Further, the Commission finds that the increase in rates and charges authorized herein are justified and that present rates and charges, in so far as they differ from those herein authorized, will become unjust and unreasonable on such date as extended service is provided. Good cause appearing, therefore,

IT IS ORDERED as follows:

1. The Pacific Telephone and Telegraph Company is authorized and directed to file in quadruplicate with this Commission, after the

effective date of this order, on or before December 31, 1961, and in conformity with the provision of General Order No. 96, tariff sheets revised to reflect rates and charges for extended telephone service in its Pinole exchange as set forth in Appendix A attached to this order and, on not less than five days' notice to the public and this Commission, to make said revised tariffs effective coincident with the introduction of extended service between Pinole and Richmond exchanges.

- 2. Coincident with the effective date of the revised tariffs above authorized, applicant is authorized to do the following:
 - a. Cancel and withdraw message toll telephone service rates between Pinole and Richmond exchanges.
 - b. Expand the local service area of Pinole exchange to include Richmond exchange.
 - c. Expand the local service area of Richmond exchange to include Pinole exchange.

The effective date of this order shall be twenty days after the date hereof.

RATES
