## OPINION

By this application authority is requested to add a one-block extension, along 8th Avenue and between C Street and Broadway, to Route "10" - DOWNTOWN SPECIAL in order to enable applicant to schedule a trip leaving the El Cortez Hotel after lunch time, which would be operated via a more direct return trip to the Civic Center by way of 8th Avenue, Broadway, and Pacific Highway instead of the present route via C Street, 12th Avenue, Broadway and Pacific Highway.

Applicant alleges that the general public will not be inconvenienced by the route change for this one trip because a three-day passenger count, January 13, 14 and 15, 1960, showed a daily average of less than 1.0 eastbound passengers and 1.3 westbound passengers using the line between 8th and 12th Avenues on Broadway.

The application is not opposed and will be granted. A public hearing is not necessary.

## ORDER

Application having been made, the Commission being fully advised in the premises and finding that public convenience and necessity so require,

IT IS ORDERED that applicant shall operate its passenger stage service on Route "10" - DOWNTOWN SPECIAL line along the streets as set forth in Appendix A, Second Revised Page 28, attached hereto and made a part hereof.

IT IS FURTHER ORDERED that, within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and to the public, applicant shall amend its tariff and time schedule to reflect the authority herein granted.

The effective date of this order shall be the date hereof.

## ROUTE "10" - DOWNTOWN SPECIAL

From the intersection of Broadway and Pacific Highway, loop via Pacific Highway, Ash Street, Harbor Drive, and Broadway to Pacific Highway, then via Broadway to 12th Avenue.

Also, from the intersection of Broadway and 7th Avenue, northbound only via 7th Avenue, Beech Street, 8th Avenue, C Street, and 12th Avenue to Broadway.

Also, from the intersection of C Street and 8th Avenue, southbound only via 8th Avenue to Broadway.
