BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of SAN DIEGO TRANSIT SYSTEM, a corporation, for authority to reroute some of its "school routes", to abandon others, and to establish new "school routes".

Application No. 41960

#### OPINION

By the application herein, filed with this Commission on February 16, 1960, San Diego Transit System, a passenger stage corporation, seeks authority to modify 13 of its authorized school routes and add two new school routes. The existing routes to be modified are described in Section 4 of Appendix A to Decision No. 55090, dated June 4, 1957, in Application No. 38858. Applicant has a total of 18 school routes at present, of which 17 are described in said Decision No. 55090, and one is described in Decision No. 59241, dated November 10, 1959, in Application No. 41622.

A copy of the application was served on the San Diego City Clerk, the City of San Diego City Traffic Operations Engineer and the San Diego Unified School District by mail on February 3, 1960.

No protests have been received by the Commission.

Applicant alleges that the proposed changes are not competitive with any other carrier. No changes in fares or equipment are proposed.

The reasons for the proposed changes are set forth in the application and need not be set out herein. Suffice to say that the

Commission having considered the matter is of the opinion and finds that public convenience and necessity require that applicant extend service as proposed in the application and that the abandonments of service as proposed are not adverse to the public interest. A public hearing is not necessary.

#### ORDER

An application having been filed, the Commission having found that public convenience and necessity require that applicant should extend service as proposed in the application and that the proposed abandonments of service are not adverse to the public interest, and based on said findings,

#### IT IS ORDERED:

- (1) That a certificate of public convenience and necessity be, and it hereby is, granted to San Diego Transit System, a corporation, authorizing it to establish and operate a service for the transportation of persons as a "passenger stage corporation", as defined in Section 226 of the Public Utilities Code, between the points and over the routes more particularly set forth in Appendix A attached hereto and made a part hereof, subject to the conditions and restrictions as set forth in said Appendix A.
- (2) That Appendix A to Decision No. 55090 is hereby amended by incorporating therein the following revised and original pages which are attached hereto and made a part hereof:

- (3) That prior to the discontinuance of any service pursuant to this decision, applicant shall post notices of such discontinuance in all buses used in the portions of routes to be abandoned, and at each stop where service is to be discontinued. Such notices shall remain posted for at least ten days prior to any discontinuance of service as herein authorized.
- (4) That in providing service pursuant to the certificate herein granted, San Diego Transit System, a corporation, shall comply with the following service regulations:
  - a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 98. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Order No. 98, may result in a cancellation of the operating authority granted by this decision.
  - b. Within sixty days after the effective date hereof, and on not less than ten days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate and concurrently make effective, tariffs satisfactory to the Commission.

The effective date of this order shall be twenty days after the date hereof.
