OPINION AND ORDER

The Pacific Telephone and Telegraph Company filed this application on April 7, 1960, seeking authority pursuant to Section 851 of the Public Utilities Code to sell certain private mobile radiotelephone equipment to Lee Boyd, doing business as Buster Equipment Company.

Applicant states that it is now furnishing part of this equipment to purchaser on a lease-maintenance basis under a contract dated November 27, 1953, as modified, and part under filed tariffs; that the book cost of the equipment is approximately \$12,300; that purchaser has agreed to pay and it has agreed to accept the sum of \$2,850 for the equipment; and that consummation of this transaction will not impair its operations or its abilities to perform its duties to the public.

For the reasons stated in Decision No. 59031, dated September 22, 1959, in Application No. 41211, the order herein will provide that applicant shall submit a cost determination showing any unrecovered costs related to this sale of private mobile communications equipment.

The Commission has considered this matter and is of the opinion that the granting of the application subject to the conditions set forth herein is not adverse to the public interest and that a public hearing is not necessary; therefore,

IT IS HEREBY ORDERED that after the effective date of this order and on or before September 30, 1960, applicant is authorized to sell to Lee Boyd, doing business as Buster Equipment Company, for \$2,850 the private mobile communications equipment described in Exhibit A attached to the application, subject to the following conditions:

1. Applicant shall prepare and submit to this Commission a cost determination showing, with supporting detail, any unrecovered costs related to this sale of equipment, computed as described in Decision No. 59031 of this Commission.

2. Applicant shall account for the sale of operative public utility property herein authorized in accordance with the "Instructions for Telephone Plant Accounts," Section 31.2-25, subsection (g) as set forth in the Uniform System of Accounts for Class A and Class B Telephone Companies prescribed by this Commission effective January 1, 1958. Applicant shall furnish to this Commission a copy of the journal entry or entries used to record this sale on its books of account.

3. Within thirty days after the authority herein granted is exercised, applicant shall notify this Commission in writing of the date of the completion of the sale of property herein authorized and of its compliance with the conditions hereof.
